

READY FOR 100

On April 8, 2019, Plymouth Council adopted Resolution 2019-16 dubbed the "Ready for 100 Renewable Energy Resolution". This resolution was brought to Council by the Township's Environmental Advisory Board and imparts a vision for a 100% clean renewable energy future.

The Township has demonstrated a commitment to reducing its energy usage by implementing energy efficiency improvements in multiple areas, including: Municipal building energy efficiency improvements, resulting in reduced energy usage and energy costs; Lighting and energy system improvements at the Community Center, resulting in reduced energy usage and energy costs; LED traffic lights throughout the Township; and transitioning to LED streetlights, all resulting in reduced energy usage and energy costs.

Going forward, Plymouth Township will join other leading towns and cities in the National Ready for 100 Movement, to transition to 100% clean, renewable energy for all, and complete this transition to: 100% clean renewable electricity by 2035; 100% clean renewable energy when replacing heating system and transportation equipment by 2050; and as vehicles are replaced, priority will also be given to transitioning the Plymouth Township fleet to 100% renewable energy sources by 2030 where feasible.



Calling 9-1-1 from a Cell Phone

The Montgomery County Department of Public Safety asks that anyone who calls 9-1-1 from a cellular phone in communities near the County border immediately state that "I'm calling from Montgomery County" when the call-taker answers the phone.

If the nearest cell tower to where the call is placed is across the border in a neighboring county, the call will be routed to the 9-1-1 centers in Philadelphia, Bucks, Berks, Chester or Delaware counties, depending on where the tower is located.

The neighboring 9-1-1 centers will transfer the call to Montgomery County, but the time it takes to figure out the actual location, transfer the call and then supply the information about the incident again, could make a difference in saving someone's life.

Stating "I'm calling from Montgomery County" at the outset will greatly reduce any delay in getting people the help they need. Cell phone calls to 9-1-1 do not give your address or location, so be sure to give that information as well.

Using a landline to call 9-1-1 will result in the call automatically being routed to the proper call center.

Please remember to pick up after your dog.

Dog owners are reminded of the following sections of the Township's General Laws:

Section 4-42. Defecation by dogs – Deemed a nuisance. Defecation by a dog in the gutter, street, public sidewalk, or other area within the right-of-way line of any public street, or upon the floor or stairway of any building or place frequented by the public or used in common by tenants, or upon the outside walkways, driveways, alleys, curbs, or stairways of any building abutting on a public street or park, or upon the grounds of any park or public area, or upon any private property other than the property of the owner of such animal, shall be deemed to be the commission of a nuisance.

Section 4-43. Responsibility of owner to remove. The owner of a dog or the person having custody or control of such dog at the time the animal commits a nuisance by defecating in any area other than on the private property of the owner of that animal shall be required to immediately remove the excrement from the surface of the ground and to dispose thereof either in a toilet or by placing the same in a non-leaking container and depositing that container in a trash or litter receptacle.

Section 4-44. Penalty for failure of owner to remove. The failure of the owner of a dog or of the person having custody or control of that animal to abate the nuisance described herein as required hereby shall be a summary offense, punishable as prescribed in section 1-9 (a fine not to exceed \$1,000 per day) of the

Plymouth Township Code.

Grant Corner Harriet Wetherill Park (HWP) Nature Center

The bid process has begun for the courtyard back entrance to the nature center. The project was partially funded by the a Department of Community and Economic Development grant through the Greenways, Trails and Recreation program. The entrance will allow easy and safe access to the building and we hope to have it completed by the end of the year.

Through a Lowe's Charitable and Educational Foundation grant, we were able to purchase materials and supplies to further improve the courtyard and nature center to accommodate our programs. Look for more exciting programs this fall and in 2020.

"So there's a smooth transition, we wanted to go ahead and hire a new fire marshal," Higgins said.




Township Recognitions







Harmonville Fire Company

Good day from the officers and members of the Harmonville Fire Company No. 1. The Harmonville Fire Company proudly protects and serves the residents and businesses of Plymouth Township, surrounding communities and parts of the Pennsylvania Turnpike since 1924. We operate out of two stations located in Plymouth Township, our main station which is located at 2100 Butler Pike and our substation located at 904 Germantown Pike. With these two locations, our members are always ready to respond at a moment's notice.

The first half of 2019 has been steady for us. We have responded to over 250 calls for service and attended 35 training sessions. Members have attended multiple special services ranging from meetings and fire prevention activities including Plymouth Township Day to summer camps to discuss fire prevention.

A new piece of apparatus is coming to our fleet! Rescue 44, a 2000 New Lexington Rescue truck is being replaced with a 2019 Pierce Rescue truck, which will be arriving this fall. The truck committee and the membership have put in a lot of time and effort to design the best vehicle for us to help serve you and our community. Stay tuned for more information about our new truck on our social media pages.

Being a volunteer organization, we are always looking for new members to join our firehouse family. There are many roles that we fill. Our Firefighting/ Rescue Operations train in saving lives and protecting property to keep the community we serve safe! This role has various job duties including forcible entry, fire extinguishment, search and rescue, and driving and operating the apparatus. Our Junior Firefighter program is for 14-17 years old who are interested in joining the Fire Company. The Fire Police Unit helps keep our firefighters, as well as the public, safe at emergency scenes by providing traffic

and crowd control. Our administrative group keeps the company running, from meetings within the company to meetings with Plymouth Township Council. They are the ones who are "behind the scenes" making sure we can be the best we can be! If you are interested in joining to help out in any way you can, you can stop by either station during the day Monday through Friday, stop by our main station Monday nights (our drill night) between 6:30 – 10:00, or visit our website, Facebook, Instagram or Twitter, leave us a message and someone will be in touch with you.

Lastly, our biggest fundraiser of the year is approaching, our Annual Christmas Tree Sale! The sale will begin at the end of November. Besides selling trees, our members hand make wreaths and sprays and have other items for sale such as tree bags and stands. And while we are on the Christmas topic, don't forget to keep an eye and an ear out for Santa Claus whom we escort around town during our tree sales. When the time gets closer, we will announce it on our social media pages.

Plymouth Ambulance

Plymouth Community Ambulance Association (PCAA) has been providing emergency medical assistance to the residents and visitors of Plymouth Township since 1963. PCAA responds to approximately 15,000 emergency calls annually,

making PCAA the busiest ambulance squad in Montgomery County. PCAA has grown since its inception in 1963, when it started out with only one ambulance. PCAA now operates a fleet of 12 advanced life support equipped ambulances, three supervisory sport utility vehicles, one F250 utility pickup which is used to pull rehabilitation trailers and a Polaris off road six-wheeled all terrain ambulance.

PCAA is headquartered at 902 Germantown Pike and operates three satellite stations to provide rapid response throughout the coverage territory. The coverage territory has also grown over time with other ambulance services going out of business. In 2000 PCAA acquired the Norristown area formerly covered by Montgomery Hospital Paramedics. In 2002 after 43 years of service West Norriton Ambulance folded and PCAA began coverage of this area. In 2014



Lower Frederick Regional Ambulance approached PCAA to discuss a merger and this area was acquired. As of today PCAA provides emergency medical service to the following areas: Plymouth Township, East Norriton Township, West Norriton Township, Municipality of Norristown, Lower Frederick Township, Schwenksville Borough, and partial areas in Worcester Township, Perkiomen Township, Upper Frederick Township, Upper Salford Township and Limerick Township, along with long stretches of the Pennsylvania Turnpike, Northeast extension and Blue Route.

PCAA provides specialized medical support to the Montgomery County Sheriff's Department Bomb Disposal Team and Montgomery

OPERATIONS:

Plymouth Fire Company is very proud to be a part of the Emergency Services providing Fire and Rescue services to the residents and visitors of Plymouth Township since 1906.

With heavy rainfall presenting unique challenges with the Plymouth Creek and Schuylkill River, we have trained and certified our firefighters in Swift Water Rescue and Emergency Boat Operations to develop our Water Rescue Team.



TRAINING:

Our firefighters continue to improve their knowledge beyond their initial certification through our weekly training night. Our training committee develops our weekly training and drills to challenge our firefighters. This enables us to increase our knowledge and skills to safely mitigate an incident.

COMMUNITY EVENTS:

We participate in public functions throughout the year that include fire prevention activities in schools, summer camp visits, Plymouth Township Day, safety days at multiple businesses, and the Plymouth Ambulance Toy Drive. For the holidays we host a Breakfast with Santa and also provide an escort for Santa through town. We are partnered with Central Montco Technical High School Public Safety program to supply some classroom instruction and equipment displays. We have a partnership with SafeKids of CHOP for free car seat inspections at our station three times per week.

HALL RENTALS:

Our banquet hall is available to rent for functions such as parties, business meetings, and luncheons. For more information on renting the hall, visit plymouthfireco.com or contact our hall rental direct line at 484-614-7578.

LADIES AUXILIARY: The Auxiliary sponsors fundraising events to bring our community together. We will host our annual Trivia Night on March 6, 2020. Enjoy trivia? Code Red is the name of the Township's emergency notification system. Residents can go to the Township website at www.plymouthtownship.org and click the Code Red logo on the homepage or text 'PLYMOUTHTWP' to 99411 from your mobile device. You will be linked to the Code Red's site where you can enter additional phone numbers and email addresses to receive emergency and community service announcements from the Township, such as evacuation notices, bio-terrorism alerts, boil water notices, mosquito spraying notices and missing child reports, to name a few.

Zoning and Planning Office



Anyone interested in conducting a "no-impact" home-based business, must apply for a Zoning Use & Occupancy Permit with the Township as well as meet the following requirements:

1. The business activity shall be compatible with the residential use of the property and surrounding residential uses.

2. The business shall employ no employees other than family members residing in the dwelling.

- 3. There shall be no display or sale of retail goods and no stockpiling or inventory of a substantial nature.
- 4. There shall be no outside appearance of a business use, including, but not limited to, parking, signs or lights.
- 5. The business activity may not use any equipment or process which creates noise, vibration, glare, fumes, odors or electrical or electronic interference, including interference with radio or television reception, which is detectable in the neighborhood.
- 6. The business activity may not generate any solid waste or sewage discharge in volume or type which is not normally associated with residential use in the neighborhood.
- 7. The business activity shall be conducted only within the dwelling and may not occupy more than 25% of the habitable floor area.
- 8. Involves no customer, client, or patient traffic, whether vehicular or pedestrian.
- 9. Delivery and/or pickup of items from the business must not be in excess of those normally associated with residential use.
- 10. The business may not involve any illegal activity.

County Major Incident Response Team. The members of these specialized teams are highly experienced providers that train alongside the bomb technicians and police officers.

PCAA's EMS personnel deliver high quality and professional Emergency Medical Service to the residents of Plymouth Township. When 911 is activated, a series of events takes place and the result is professional help at your side in minutes during times of crisis. In order to maintain this state of readiness, our emergency medical technicians and paramedics undergo recurrent physician level educational lectures and hands-on training. Full time providers recently completed a bi-annual skills review. This training serves to refresh the knowledge of each provider as well as provide the opportunity to hone and perfect their skills with simulated real-world situations. All of this is done in an ongoing effort to provide the best EMS care possible to this community.

Along with receiving ongoing training many of our providers are instructors that are committed to furthering the medical education of township residents. PCAA offers training in CPR, AED, and first aid. If you or your business is interested in receiving this highly valuable training please contact us via phone at 610-277-2776 ext. 6 or at our website www.medic308.org and one of our training staff will be happy to get this setup.

PCAA is launching a new endeavor in effort to provide patients with the best care possible. When responding to a medical emergency we rely greatly on attaining a patient's past medical history, current medications, medical and environmental allergies and specific demographic information. This information is usually the last thing on the mind of a patient or family members when experiencing an emergency. In an effort to have this information easily accessible to our responders PCAA will be offering printable patient medical information cards. We ask that you print these cards out, fill in the needed information and keep them easily accessible. We recommend keeping these cards on or inside your refrigerator. Our providers are trained to look for the cards in this location and you can help them by advising them you have a card and where it is located. Again these cards are printable and available on our website www.medic308.org. If you are unable to print one, feel free to stop at our station located at 902 Germantown Pike and pick some up.

As a reminder we at Plymouth Community Ambulance offer certified car seat inspections. Please call a week or two in advance to schedule your inspection. You should bring your child safety seat, the vehicle the seat is being installed in, and the owner's manuals for both. Our certified safety technician will go over the proper installation of your safety seat. They will answer questions on what type and how long a child should ride in each style of safety seat. They will advise on best practices for where in the vehicle the child seat should be located. Police News

School Zone Driving Safety Tips

- Be on the lookout for school zone signals and ALWAYS obey the speed limits.
- When entering a school zone, be sure to slow down and obey all traffic laws.
- Always stop for school buses that are loading or unloading children.
- Watch out for school crossing guards and obey their signals.
- Be aware of and watch out for children near schools, bus stops, sidewalks, in the streets, in school parking lots, etc.
- Never pass other vehicles while driving in a school zone.
- Never change lanes while driving in a school zone.
- Never make U-Turns while driving in a school zone.
- Never text while driving in a school zone.
- Avoid using a cell phone, unless it is completely hands-free, while driving in a school zone.
- Unless licensed to do so, never use handicap or emergency vehicle lanes or spaces to drop off or pick up children at school.

Riding Your Bike to School

- Check with the school to make sure your child is allowed to ride their bicycle to school. Some schools do not allow students to ride bicycles to school until they reach a specific grade.
- Make sure your child always wears a bicycle helmet! Failure to wear one could result in a traffic citation. Furthermore, in the event of an accident, helmets reduce the risk of head injury by as much as 85 percent.
- Obey the rules of the road; the rules are the same for all vehicles, including bicycles.
- Always stay on the right-hand side of the road and ride in the same direction as traffic.
- Be sure your child knows and uses all of the appropriate hand signals.
- Choose the safest route between home and school and practice it with children until they can demonstrate traffic safety awareness.
- If possible, try to ride with someone else. There is safety in numbers.



Walking to School

- Leave early enough to arrive at school at least 10 minutes prior to the start of school.
- Use the same route every day and never use shortcuts.
- Go straight home after school. Do not go anywhere else without permission.
- Always use public sidewalks and streets when walking to school.



• Demonstrate traffic safety awareness and pick the safest

route between your home and the school and practice walking it with your children.

- Try and walk to school with other students. There is safety in numbers.
- Teach your children to recognize and obey traffic signals, signs, and pavement markings.
- Only cross streets at designated crosswalks, street corners and traffic controlled intersections.
- Always look both ways before crossing the street and never enter streets from between obstacles like parked cars, shrubbery, signs, etc.
- Always walk and never run across intersections.
- Avoid talking to strangers. Teach your children to get distance between themselves and anyone who tries to approach or make contact with them.
- If a stranger does approach your child, make sure they know to immediately report the incident to you or a teacher.
- Teach your children to never get into a vehicle with anyone, even if they know them, without your permission.

School Bus Safety

- Make a habit of arriving at the bus stop at least five minutes before the scheduled arrival of the bus.
- Make sure your child stays out of the street and avoids excessive horseplay while waiting for the school bus.
- Be sure the bus comes to a complete stop before getting on or off.
- When riding the bus, make sure your child understands they must remain seated and keep their head and arms inside the bus at all times.
- Do not shout or distract the driver.
- Do not walk in the driver's "blind spot" this is the area from the front of the bus to about 10 feet in front of the bus.

Public Works

Is Your Trash Can Too Big?

More and more residents are using 60-90 gallon carts as their trash container. These carts are too large for our men to handle and are designed to be lifted mechanically. Trash cans should be no larger than 30 gallons and weigh no more than 50 pounds when loaded. An EMPTY 90 gallon cart weighs 40 pounds! As a guide, the round, blue recycle cans are approximately 30-gallon size. A trashcan of this size is preferable. Trash will be left curbside and tagged if it is deemed to be too heavy.

Christmas Tree Recycling

Plymouth Township will start recycling Christmas Trees on Wednesday, January 8, 2020. Residents are asked to put their used Christmas trees out for collection as yard waste on any Wednesday. The Public Works Department will collect the trees and chip them. For the safety of Township employees, residents must remove all ornaments, lights and stands. The wood chips are turned into mulch, which is free for the taking at the Public Works driveway, 700 Belvoir Road.



Plymouth Township Mailbox Replacement Policy

Plymouth Township has many operations that require various types of vehicles and equipment to work along the street and curb line. Snow plowing in particular requires operations to get as close to the curb as possible so that mail can be delivered. The Highway Department takes great care not to damage any property within the right-of-way; however, mailboxes occasionally are damaged. Most damage occurs by the weight of the snow that rolls off the blade. Many times mailboxes are old and leaning or not installed properly. Due to the time and cost associated with these repairs and replacements, we have established a new policy for mailbox repairs and new mailbox installation.



The Policy

The Public Works Department will no longer repair or replace damaged mailboxes or support posts. Instead, when the following two (2) criteria are met, it will provide reimbursement up to a maximum of \$100.00 (copies of receipts are needed):

- 1. It is determined that the Township operator damaged the mailbox while operating a snow plow while plowing snow; and
- 2. The mailbox had been properly installed (i.e., meeting US Postal Service installation guidelines) and maintained prior to the damage occurring.

If both criteria noted above are met, you may repair or replace the mailbox/post at your own cost, the Township will then reimburse you up to the maximum of \$100.00 (copies of receipts are needed).

2019 Solid Waste Holiday Collection Schedule

- If a holiday falls on a Saturday or Sunday, the holiday is observed on Monday.
- When a holiday falls on your recycle day during the week, recycling will be picked up on Wednesday of that week. Your trash will be picked up on your next scheduled trash day.

Collection of trash will be made on the next scheduled collection day when the collection day falls on the following Township holidays:

- General Election Day Tuesday, November 5, 2019
- Thanksgiving Day Thursday, November 28, 2019
- Day after Thanksgiving Friday, November 29, 2019
- Christmas Day Wednesday, December 25, 2019
- New Year's Day Wednesday, January 1, 2020
- Good Friday Friday, April 10, 2020
- Memorial Day Monday, May 25, 2020

Snow Plowing

When it snows, our goal is to have all Township and State roads cleared within 15-20 hours after the snow has stopped falling. In order for this to occur, however, it takes your cooperation. The public works crew plows 48 miles of Township roads and 17 miles of State roads. This translates into over 150 lane miles to clear. As you can see, this is not an easy task.

If you have off-street parking such as a driveway, please use it. Please stack cars closely in your driveway and refrain from parking on the street. This will help our crew to better clear and negotiate your street.

Please do not throw snow back into the street while shoveling or cleaning off cars. This slows and impedes our operations and the plows will have to clear it again. This also violates Ordinance #1540.

Section 20-1 of the Code of Ordinances was amended to add a new subsection (e) as follows:

(e) It shall be unlawful for any owner, agent, tenant, occupant of property, person in charge of property including motels, garden apartments, high-rise apartments, multi-family dwellings, hotels and commercial properties within the Township to throw, shovel, push or plow snow into, across, or upon any roads, streets, sidewalks or Township rights-of-way within the Township.

Section 20-2 of the Code of Ordinances was amended to read as follows:

(a) In any case where the owner, agent, tenant, occupant of property or person in charge of property as described in Section 20-1(a-d), shall fail, neglect or refuse to comply with any of the provisions of such section within the time limit prescribed therein, the Township authorities may proceed immediately to cause such cleaning, clearing or removing of snow, ice, water, mud, dirt, debris or dangerous articles from the street, sidewalk or premises, and to collect the expenses thereof, with any additional amount allowed by law, from such owner, agent,

tenant, occupant of property or person in charge of property, as the case may be, which may be in addition to any fine or



penalty imposed under other provisions of this Code.

(b) In any case where the owner, agent, tenant, occupant of property or person in charge of property including motels, garden apartments, high-rise apartments, multi-family dwellings, hotels and commercial properties as described in Section 20-1(e), violates this section, said owner, agent, tenant, occupant of property or person in charge of property shall be liable to pay a fine of not more than three-hundred dollars (\$300) and not less than one hundred fifty dollars (\$150) for each and every offense. A person who receives a notice of violation of Section 20-1(e), may within 10 days of receipt of such notice, pay a reduced fine of seventy-five (\$75) dollars.

Ideally, don't shovel the end of your driveway until the plows have finished with your street. Remember, all plows are angled to discharge snow to the curb on the right. It is impossible to plow the streets without the plow being angled.

The plowing priority will be as follows: Primary roads will be cleared first, followed by secondary streets and finally residential streets and cul-de-sacs. Residential street plowing will not begin until the snow stops falling. The reason for this is because our main focus and priority is keeping the main roads passable and clear while the snow is falling. We cannot plow the residential neighborhoods while the snow is falling because the main roads would become dangerous and potentially impassable.

Remember, the public works crew will put in long hard hours clearing the streets....so please be patient and courteous.

It's Time to Get Ready for Winter

- Use off-street parking when snow is predicted. When you park your car in the driveway, there is less snow to shovel.
- On-street parking, where no off-street parking is available, is only permitted on one side of the street. In an odd year parking is only permitted on the odd numbered side of the street; in even years, the even side of the street.
- Do not park near storm drains, so crews can clear snow and ice to avoid flooding from the melting runoff.
- When shoveling your driveway, pile snow to the right. This will prevent the plow from covering your driveway opening again.
- Property owners are required to clear their sidewalks at least 30 inches wide within 36 hours after the snow stops.
- Residents are reminded that it is unlawful to park or abandon a car on any street, any time within twelve hours after a snowfall of three inches or more, where off-street parking exists. Vehicles parked otherwise are subject to removal at the owner's expense.
- Any motor vehicle parked, stalled, incapable of moving under its own power, or left unattended upon any public street or highway in the Township at any time within twelve hours after a snowfall of three inches or more has occurred, may be removed or towed to another location by the Police Department.
- Do not shovel or plow snow into the street. The plows will just move it back onto your driveway or sidewalk.
- Think Safety! Never approach moving snow removal equipment. Just because you can see the driver does not mean he can see you. We try to keep our crews fresh and rested, but extended weather emergencies can mean long hours for Township employees. Please keep children and pets off the street during snow removal operations.

If there is a fire hydrant by your home, consider adopting it! You know where it is; if it is obscured by snow, fire companies responding to emergencies may not find it. Clearing the snow from the hydrant helps protect you and your neighbors.



Free Mulch

For a delivery charge of \$30.00, the Public Works Dept will deliver up to 1 dump truck load of mulch (approx. 5 yards) to your household. There is a 1 yard minimum.

Annually the Township collects over 1,000 tons of yard waste curbside from residents. The material is stockpiled so it will break down at the public works yard. This material, along with composted leaves, is processed by our tub grinder to make mulch.

Deliveries are every Friday throughout the year from March 1 to November 1. Anyone who would like a mulch delivery must come to the public works office in person to sign a release of liability and pay \$30.00 delivery charge. Payment is due by Wednesday for Friday delivery.

Yard Waste

- Yard waste is collected every Wednesday throughout the year.
- Yard waste consists of grass clippings, twigs/shrub trimmings and pruning, leaves, and garden waste (pinecones, weeds, dead plants). Rocks and logs are not considered yard waste.
- Place in biodegradable brown paper bags or in a designated Yard Waste container (trashcan). Please, no plastic bags. Brown bags can be purchased at Home Depot, Lowes and some grocery stores.
- Yard waste will not be collected in the blue recycling containers.

Note: All recyclables and yard waste are collected in a designated trash truck as part of our single stream recycling. So rest assured that although all recycle materials will be collected with a trash truck, they are still being recycled to protect our earth and reduce disposal costs.

Branch and Chip Program Collection

- The Township runs two Branch and Chip Collection Programs during the year.
 - o Fall September 3 through October 4, 2019
 - o Spring March 2 through April 9, 2020
- Residents **must** call the Public Works Department prior to NOON on Wednesday to schedule their pick up.
- Branches will be collected on Thursday and Friday, weather permitting.
- Residents should comply with the following:
 - o Leave the branches as long as possible, a minimum of five feet in length.
 - o Nothing over five inches in diameter can be chipped.
 - o Branches should be placed at the curb in an orderly pile.
 - Please let us know if your branches have thorns so we can exercise caution when handling.

This does not include hedge and shrub clippings. If you want hedge and shrub clippings collected, please place at curb in biodegradable brown bag, in designated yard waste container or tied with biodegradable string on Wednesday for Yard Waste collection.




Leaf Collection


(Please refer to the map and tentative schedule.)

- Curbside leaf piles may extend along the entire length of the property.
- DO NOT mix limbs, brush and other debris with leaf piles. Mixed piles will not be collected.
- Leaves will not be collected with your regular trash collection. Trash with leaves co-mingled will not be collected.
- Adverse weather conditions may cause delays in leaf collection dates.
- Once the leaf collection machine has passed, it will not return until the next scheduled collection.
- Township employees and/or equipment are not permitted to enter private property to remove leaves.
- Property owners are encouraged to start their own compost piles.
- Residents can opt to place bagged leaves at the curb for collection with their yard waste on Wednesdays.

Inspection Requirements for Selling your Home

Property Sale Sewer Inspection

The owner must have the sewer lateral inspected by a licensed Master Plumber, who is registered in the Township prior to the sale of a property. It is recommended that this process start once the property is listed for sale due to the time it will take for completion, but no later than once a property has an agreement of sale. The inspection should be completed before the property is transferred.

The Plumber must video the lateral from the house to the inlet of the main to make sure there is no water infiltration or illegal hook-ups (sump pumps or storm water inlets).



Then the Plumber will prepare a report stating what is found and provide a copy of the video to the Township.

If the lateral is found to be deficient, then a permit application must be submitted and approved, prior to repairs being made. Repairs should be completed prior to transfer of the property.

Once the repairs are made, the Plumber must submit a report stating that all deficiencies have been corrected.

If the repair cannot be made prior to settlement, then a Home Sale Affidavit signed by the buyer must be submitted to the Township before a Certificate of Adequacy will be issued.

Work must be completed no later than 30 days after settlement. This inspection is in addition to the curb & sidewalk inspection.

Certificate of Adequacy

All properties must have their sewer lateral, curb and sidewalk and house numbers inspected and a "certificate of adequacy" issued prior to resale and deed recordation with the County.

CURB AND SIDEWALK INSPECTION: Township staff will perform the inspection. Damaged curbing and sidewalk meeting the replacement guidelines must be repaired in compliance with Township specifications. Properties without a curb and sidewalk will not be required to install them.

HOUSE NUMBER: Township staff will perform the inspection. Numbers must be 4" high and visible from street.

SEWER LATERAL INSPECTION: The owner must have the sewer lateral inspected by a licensed Master Plumber who is registered in the Township. If a sewer lateral is found to be deficient, then the necessary repairs will need to be made prior to transfer.

There is a \$10 fee for the Certificate of Adequacy Application. Please allow at least three weeks for the curb, sidewalk, house number and sewer lateral inspection. Do not delay, request the inspection as soon as you list your property.

Condominiums are required to have their sewer lateral inspected and the disclosure statement signed prior to resale. Curb and sidewalk inspections are exempt for private communities.

Property owners are responsible for the maintenance of the curb and sidewalk along their property. Please be sure to address tripping hazards and obstructions (including snow, ice, branches and other debris) to allow safe pedestrian passage.

Storm Water Regulations

Federal storm water regulations require Plymouth Township, as well as most other municipalities in "urbanized areas" across Pennsylvania, to comply with the Environmental Protection Agency's storm water management program. One of the many requirements of the program is to obtain a National Pollutant Discharge Elimination System (NPDES) permit. The program in Pennsylvania is administered by the Pennsylvania Department of Environmental Protection (DEP). Plymouth received its permit on January 15, 2004. The Township is in the process of implementing the storm water management protocols developed by the DEP.

Under the DEP program, Plymouth Township will implement the six required Best Management Practice (BMP) control measures, including Public Education, Public Participation, Illicit Discharge Detection and Elimination, Construction Site Run-off Control, Post Construction Storm Water Management, and Pollution Prevention and Good Housekeeping for Municipal Maintenance.

An important part of the Township's compliance plan is to educate the public regarding the environmental impact of storm water run-off. The PA DEP maintains a website with comprehensive information on storm water education (www.dep.state.pa.us). The Plymouth Township website (www.plymouthtownship.org) also has information and links to other websites.

We also ask that residents report any suspected pollution incidents to the Township at 610-277-4103. This includes the dumping of wastewater, illicit liquids or solids into streams or storm sewers.

Township Continues To Battle Sewer Inflow and Infiltration

The Township is continuing its efforts to prevent unwanted storm water from entering the sanitary sewer system. We continue to inspect and repair manholes and sewer lines throughout the Township in an effort to remove as much storm water Inflow and Infiltration (I&I) from the system as possible.

The Township pays to have waste water treated, resulting in higher sewer rates for everyone. In addition, increased wet weather flows can overload pump stations and other facilities. This leads to sewer overflows, which can cause environmental and other health hazards, as well as costly property damage. It can also lead to expensive facility upgrades, which result in higher sewer rates.

Are you aware that it is illegal to have your sump pump or roof drains connected to the sanitary sewer system? Illegal connections



put unnecessary rainwater into the Township's sanitary sewer system.

What can you do to help? Make sure your sump pump and roof drains are not connected to the sanitary sewer system. Down spouts and sump pumps should be connected to the storm sewer system, or directly discharge to a lawn area where they can flow to the street. Keeping rainwater out of the sanitary sewer system will help keep rates from rising unnecessarily.

In addition, residents should check their sewer vents to make sure the vent cap is properly in place. The area around the vent should also be checked to ensure that it is graded to prevent runoff from entering the sanitary sewer system.

If you need help with suggestions on where to re-route your sump pump discharge or repair your sewer vent, please call the Plymouth Township Public Works Department at 610-277-4103.

Trash Collection

Place trash at curb no later than 6:00 a.m. on the day of collection, but no earlier than 7:00 p.m. on the prior evening.

- Store in water-tight containers with handles and loose fitting lids. Do not place trash in paper bags, plastic bags or cardboard boxes.
- If the trash men spill trash, they will pick it up; if an improper container breaks or an animal tears up the trash, it is the property owner's responsibility to clean up.
- The trash men will not collect more than four containers. Trash containers should be no larger than 30 gallons nor weigh more than 50 pounds.
- Unacceptable items include refuse from the construction of buildings such as sand, earth, lumber, brick, stone, mortar, plaster, roofing materials, plumbing fixtures, etc., auto parts, hazardous wastes, household appliances, and yard waste.
- Large items such as furniture will be picked up on your second regular trash day of the week.
- Household appliances and scrap metal are collected separately from regular trash.

Recycling



Recyclables are collected once a week on your designated recycling day.

 Place items in the blue recycling container no later than 6:00 a.m.; additional containers may be used, but must be marked for recycling. Recycle stickers are available at the Township Building at no charge.

- PLEASE DO NOT PUT RECYLCING IN PLASTIC BAGS. Place all recycling LOOSE in recycle can.
- Large cardboard items may be placed next to the containers.
- Damaged containers can be exchanged at no cost; lost containers will be replaced at \$25.00 per container.
- Blue recycle containers are for single stream recycling ONLY. Yard waste or trash will not be accepted in this container.
- The following items are recyclable:
 - o Glass
 - o Aluminum and Bimetal Cans
 - o Paper and cardboard No pizza boxes
 - o Plastic (#1 thru #7) No plastic bags

White Goods Collection Fee -Household Appliance & Scrap Metal Collection Fee: \$10

The Township has a separate collection for stoves, freezers, refrigerators, washing machines, dryers, metal cabinets and all metal furniture, because these items are not accepted at the trash-to-steam plant.

These items are picked up once a month on the third Wednesday of the month. Residents desiring to have an appliance removed must call the Public Works Department by the second Friday of the month at (610) 277-4103 to get the \$10 disposal sticker and to be placed on the list. Items without stickers will not be collected. Once stickers are purchased, there are no refunds.

Dishwashers can be put out on your second regular trash day.

Television and Monitor Collection Fee Electronics and Universal Waste Drop-Off Electronics are required by Law to be recycled under the Covered Device Recycling Act of 2010. They will

The Township has an electronics (covered devices) and universal waste drop-off located at the Public Works Shed at no cost to Township residents. (Excluding televisions and monitors)

not be accepted in regular trash.

Televisions and monitors can be dropped off at the Publics Works Shed for a fee of \$20 or we will pick televisions up curbside on the third Wednesday of the month for a fee of \$30. Residents desiring to have a television removed must call the Public Works Department by the second Friday of the month at (610) 277-4103 to get the \$30 disposal sticker and to be placed on the list. Items without stickers will not be collected. A disposal sticker is required for the televisionsonly curbside collection. Once stickers are purchased, there are no refunds. All other covered devices must be brought to the Public Works Shed, Monday through Friday, between 8 a.m. and 3:30 p.m. or taken to a Montgomery County sponsored Electronics Waste Collection site on a Saturday.



Generato

Downed utility lines, power company blackouts, heavy snow falls or summer storms can all lead to power outages. Many people turn to their portable generator for a temporary solution without knowing the risks.

- Generators should be used in well ventilated locations away from all doors, windows and vent openings.
- Never use a generator in an attached garage, even with the door open
- Place generators so that exhaust fumes can't enter the home through windows, doors or other openings in the building.
- Make sure to install carbon monoxide (CO) alarms in your home. Follow manufacturer's instructions for correct placement and mounting height.
- Turn off generators and let them cool down before refueling. Never refuel a generator while it is running.
- Store fuel for the generator in a container that is intended for the purpose and is correctly labeled as such. Store the containers outside of living areas.

Just Remember...

When plugging in appliances, make sure they are plugged directly into the generator or a heavy duty outdoor-rated extension cord. The cords should be checked for cuts, tears and that the plug has three prongs, especially a grounding pin.

If you must connect the generator to the house wiring to power appliances, have a qualified electrician install a properly rated transfer switch in accordance with the National Electrical Code[®] (NEC) and all applicable state and local electrical codes.
