This is to inform you that Plymouth Township will **NO LONGER** be collecting Real Estate Tax payments. The Township has appointed **H.A. Berkheimer**, **Inc.**, **(Berkheimer)** to be in charge of collections from this point until otherwise noted. Residents will now be receiving their tax bill from Berkheimer and all Real Estate Tax payments must be remitted to Berkheimer, as Plymouth Township will no longer accept any payments in person or through the mail.

The following are ways to make your Real Estate Tax payment to Berkheimer:

2022 ANNUAL REPORT

TOWNSHIP MANAGER

The Township Municipal Building and Public Works Garage renovation began in April 2022 and is on schedule to be completed by the end of October 2023. The Code Enforcement Department temporarily relocated to the Greater Plymouth Community Center in the Fall of 2021. The project is taking place in phases to accommodate the rest of our employees working in the building during construction, with the first phase nearing completion. Progress to date includes: over 35 wells drilled for the geothermal HVAC system, new water service, new electric service, a new roof over the auditorium and administration wings, an ADA compliant floor for the auditorium, and work on separate entrances to the police and administration wings.

In July, the Township purchased the last parcel on Germantown Pike, between Jolly and Walton Roads, not already owned by the Township. The home will be demolished and .46 acres of open space will be added to Community Center Park.

There were two ordinances adopted by Council pertaining to new uses in zoning districts. The first was to add Life Sciences as a permitted use in the Mixed Use Planned Development District and the Office Laboratory District. The second was to allow apartments, with restrictions and by Conditional Use, in the Shopping Center District.

The 2023 budget, adopted in December 2022, had a .1 mil increase to help pay the debt service on the Municipal Campus renovation. Even with this slight increase, Plymouth Township residents have the 7th lowest total real estate tax bill, including County and School taxes, out of the 62 Montgomery County municipalities. When you factor in that trash collection is included in the taxes residents pay, Plymouth ranks even lower.

2022 was the first year that Berkheimer collected real estate taxes and Tri-State collected business taxes for the Township. It was a smooth transition.

We are extremely fortunate to have two volunteer fire companies to protect the Township 24/7/365. As with any volunteer organization, it is difficult to recruit and retain volunteers. Besides weekly training, almost 200 hours of training are required for a Firefighter I certificate, and that's just the beginning of training for a firefighter. In an effort to retain volunteers at Plymouth and Harmonville Fire Companies, the 2023 Budget includes a .72 mils Fire Services Fee to assist in covering the cost of fire apparatus and fire station expenses. The appropriation to the fire companies also covers a program to reward the active volunteers with a small stipend per call, training or special service event. Both fire companies signed an agreement to place Plymouth Township as a lienholder on the titles to all vehicles, thus preserving the

investment in the apparatus. The Township currently holds the titles for safekeeping.

I am so grateful for the dedicated department directors and employees who are very talented and always professional in their daily work. I would also like to thank Council and all of our citizen volunteers for their dedication and commitment to making Plymouth Township a terrific community. It is my pleasure working with you and for you.

PUBLIC WORKS

The Public Works Department continued its efforts to upgrade, maintain and expand the Township's roadways, storm sewers, and other infrastructure throughout the year. Ongoing efforts to reduce Inflow and Infiltration in the sanitary sewer system continued. Red Zone Robotics has proven instrumental by televising and analyzing over 60 miles of sanitary sewer to better help the Public Works Department prioritize and maintain its infrastructure. The Township has a \$400,000 budget to line our sanitary sewers with a process called CIPP (cured in place pipe). This will adhere to the inside of our aging sewer lines to form a continuous pipe from manhole to manhole. This process does not require any excavating and therefore is saving millions of dollars.

In advance of the annual street paving project, many storm inlets were repaired and upgraded, others throughout the Township were also repaired or replaced, if needed.

The Annual Street Paving was completed this year on Ashwood Lane, Loretta Drive, Timberfare Circle, Beacon Hill Circle, Beacon Hill Lane, Plymouth Rock Road, Revere Circle, a portion of Jolly Road and a portion of Sierra Road, and all of Brook Road.

Many water mains throughout the Township were replaced in 2022 and will continue in 2023 as part of Aqua PA infrastructure improvements.

Peco Energy has also replaced many old bare steel gas mains throughout the Township. They will continue in 2023.

Electronics collection drop-off continues to grow in Plymouth Township. This new program collects televisions, electronics, computers, small appliances and rechargeable batteries, just to name a few.

The department continued routine operations including trash, recycling, yard waste and white goods collection, chipper programs, leaf collection, electronics collection, mulch delivery and composting. Covid saw a rise in trash tonnage by 500 additional tons. This appears to be the new normal as more people are now working from home.

Short lines were again painted this year on all traffic signals and non-signalized areas.

The Mulch/Compost delivery to residents program made record deliveries free of charge to residents last year due to Covid. Over 500 yards of mulch/compost was given back to residents through our delivery service. Mulch was also free of charge at our community mulch pile.

Our new Horizontal Grinder has made easy work turning yard and leaf waste into mulch. We took possession of the grinder in 2021. This machine is a state of the art grinder that turns yard waste, wood chips and leaves into a rich mulch/compost.

Recycling Overview

Recycling is of great importance to the Plymouth Township community. Our success in our recycling programs relies heavily on procuring collection equipment that provides efficiency, ease of collection, and provides capacity for collected materials all the while making safety a priority. The Public Works Department recently received another grant for a new swaploader with leaf vacuum. The single man operation swaploader is our fourth like machine making leaf collection a much easier task compared to when it was a three man operation for each leaf unit.

Plymouth Township continues its recycling consistency, sustainability and pursuit to become a perennial recycling leader in Montgomery County and the State of Pennsylvania. Over the last 2 decades Plymouth Township has proven outstanding recycling achievement in many categories, such as single stream recycling, composting, public education, special collection, reuse, waste reduction and proper disposal. Plymouth Township has enthusiastically embraced recycling since Act 101 was adopted. We own our sanitation trucks and equipment, and use municipal staff for collection and disposal. We can respond quickly to environmental mandates and resident needs. Plymouth Township focuses and prides itself on tailoring multiple recycle programs that fit the needs of the community which it serves. All of these recycling services, with the exception of Electronics Collection drop-off at our facility, are performed by Township employees. Besides our drop-off facility, in 2014 the Township started a new pick-up program for televisions and large electronics on every third Wednesday of the This has proven to be a huge success for Plymouth Township. Despite the difficulty state-wide in disposing of covered devices, especially tube televisions and monitors, Plymouth Township has successfully continued to recycle these items while others are still searching for a way to dispose of them. When other Municipalities are cutting programs to save money, Plymouth Township continues to embrace the benefits of recycling.

The following are highlights from last year's recycling efforts (2022) and the incredible cost savings that have been achieved through recycling.

2022 consistency and recycling success continues in Plymouth Township. Again through education in the newsletter, cable access channel and word of mouth, all of our recycling programs continue to be popular among our residents. Plymouth Township's recycling program is often used as a model for other Municipalities to follow.

In 2022 the Single Stream recycle program collected 1,200 tons. Just a few years ago, this tonnage only topped out at 941 tons. We continue to focus on reducing the residue in recycling so our recycle center will have less trash and more recycling.

Plymouth Township continues to have a separate collection for yard waste. This yard waste is collected every Wednesday throughout the year. In 2022, the Public Works Sanitation Dept. collected 1,100 tons of yard waste. In years past, much of this material was discarded in the trash. This diversion is a reduction of \$60 per ton, saving the Township \$60,000 in potential trash disposal fees. This program is in addition to our fall curbside leaf collection totaling 1,900 tons and our 6-week spring and 6-week fall branch and chip program where we collected another 70 tons. All of this material is processed at our public works yard with our horizontal grinder that we share with Whitemarsh Township. This mulch is then available to our residents for pick up at the Township building at any time.

Also, for a \$30 delivery charge we will deliver processed mulch, up to 5 yards, to any Plymouth Township residence. In 2022, over 100 deliveries totaling more than 700 yards of mulch were given back to the residents of Plymouth Township. In addition, hundreds of yards were picked up at our community mulch pile.

We also have a white goods appliance and metal collection once a month. This collection added another 15 tons of material that was diverted from entering the trash stream.

Our Electronics Recycling Program is gaining in popularity. Residents can simply drop-off all e-waste, rechargeable batteries, small appliances, wire, plastic, televisions, etc. to the Township for proper recycling, thus diverting this material from entering the trash stream. This e-waste is processed by an outside agency, Magnum Computer Recycling at no cost for all electronic items including televisions. In 2022, the Township collected 13.5 tons of electronics from residents.

POLICE DEPARTMENT

Although our numbers were depleted by long-term injuries, we increased our membership by two sworn officers and one civilian employee. As our complement returns to full strength, we will be better situated to implement both our safety and traffic calming initiatives.

Our commitment to excellence, blended with a diverse body of individuals, serves to strengthen our agency as well as enrich our community.

A hard-earned endeavor, one that is both gratifying and essential, is the bolstering of our community trusts. Through alliances with the Colonial Area Anti-Racism and Social Equity Alliance (CAARSEA), Laurel House, our Emergency Service companions, and the District Attorney's Office, we were honored to collaborate on numerous community concerns:

Likewise, we successfully collaborate only through the leadership and support of Manager Karen Weiss and Plymouth Township Council.

Lastly, a tribute to the men and women of the Plymouth Township Police Department: I am forever grateful for your selflessness, devotion, and the bravery exhibited by each and every one of you. Your service and sacrifice to the Plymouth Township community is prized.

PARKS & RECREATION

2022 was a very exciting year for the Parks and Recreation Department. Our post-COVID recovery continued as GPCC saw growth in attendance, programs filled again and we offered new options. Over 200,000 visits were tallied to GPCC.

The Township cut the ribbon on two new playgrounds. Alan Wood Park opened in the spring and East Plymouth Valley Park opened in the fall. The EPV playground is the first fully accessible playground in our community. The projects were funded by the Township, private donations, and State of PA Grants.

Numerous programs that returned to the Township in 2021 saw an increase in attendance this year. Veteran's Day, Plymouth Township Day, sports leagues, and holiday tree lighting all saw growth in participation. We also hosted PIAA District 1 and State Playoff baseball games at the GPCC baseball field.

Summer Camp and playground program (which has been held in the Township since the 1950s) returned with strong participation this summer. Campers once again swam and went on field trips and other traditional camp activities that had been curbed by the pandemic the past few summers.

During 2022 we added a community yard sale in cooperation with Whitpain Township, continued our movies and concerts, and instituted a bingo night. Our pool special events also returned with some new offerings. Kickboxing was added to our fitness classes. Thanks to many community businesses our sponsorship program has grown to allow us to enhance our activities.

We are looking forward to offering new programs and services in 2023. Please continue to check our brochure and social media accounts for updates.

Plymouth Township Environmental Advisory Board Single-Use Plastics Study

We are reaching out to our valued Plymouth Township businesses to keep you informed of our single-use plastics study.

We see local businesses as valuable partners in our effort to reduce the impact of single-use plastics in our community. Restricting the use of single-use plastics will save on the cost of procuring bags and reduce litter in our shopping areas.

Resources we will provide

One part of our initiative to enact a single-use plastics restriction is to provide resources and informational pages to educate customers. Based on implementation in other municipalities, customers may question the change at first, but quickly adapt.

We will compile and share information on vendors who supply bags that meet the criteria for reusable and paper bags. Customers who do not have a reusable bag may request a more sustainable bag at a nominal fee that goes to the business. The fee helps offset the cost of the bags provided by your business. Having a nominal fee on the cost of the bag will encourage the public to consider more environmentally friendly options such as bringing reusable bags to shop.






Last year the Harmonville Fire Company responded to another record-breaking number of calls for assistance. We responded to 775 emergency calls, which is an increase of 65 responses from the year 2021, ranging from fire alarms to building fires or vehicle accidents. The Harmonville Fire Company No.1 takes great pride in training our members to ensure they are prepared for any emergency they may be called upon to answer. In 2022, we undertook a rigorous training schedule. The Company trained for 2,748 hours with many of those hours outside of the company Monday night drills. This year, four new Harmonville Fire Company No.1 members completed State certified Firefighter 1 certification. We could not be prouder of these members and the dedication they

showed to help support the mission of Harmonville Fire Company No.1. Harmonville is also proud of its Advanced Heavy Rescue Certification through the Pennsylvania Department of Health and the State Fire Commissioner's Office. We also attended approximately 60 events during the year totaling over 800 man hours of dedicated time. Our members love to be hands on and teach everyone about fire safety and what to do in case their home was to ever be on fire.



Our yearly fund drive was sent out towards the end of last year and we would like to thank everyone who sent a donation. Our annual Christmas Tree Sale was another huge success. We sold out of trees in just 15 days! Also during our tree sale, we collected new unwrapped toys. These toys were distributed to Bryn Mawr Hospital & St. Christopher's Hospital for Children as part of the Plymouth Ambulance 10th Annual Operation Christmas Kids Toy Run, and to A.I. Dupont Hospital for Children. Lastly, our annual Easter Flower- Sale is approaching and will be held starting the Thursday before Easter.



HARMONVILLE FIRE COMPANY

Harmonville received multiple grants from FEMA, the Office of the State Fire Commissioner, the Redevelopment Assistance Capital Program (RACP), and finally a Department of Community and Economic Development (DCED) grant. The FEMA Assistance to Firefighter Grant (AFG) was awarded to HFC in August of 2022 for \$45,266.66. This grant will be utilized to install a breathing air compressor in our main station. The PA State Fire Commissioner's grant was used to help replace aging fire supply hoses on our attack fire engines.



Fire House Replacement Project

With the aging infrastructure of our Plymouth Valley station, the fire company has initiated a committee to look into and start planning on how we will continue to serve the Plymouth Township community for the next 50-100 years out of this station. After many meetings with Engineers, Architects, and fire company personnel, it has been concluded that there needs to be a total replacement of our Plymouth Valley Station. During many of these meetings, Township and State officials visited to discuss these plans with our committee and to develop a plan for funding such a project. It is with great success we were awarded two major Grants to help support this project. Harmonville received both a Redevelopment Assistance Capital Program (RACP) in the amount of \$1,975,000 and a Department of Community and Economic Development (DCED) grant in the amount of \$200,000. It is not without the unwavering support of State Representatives Matthew Bradford, Mary Jo Daley and State Senator Amanda Cappelletti that these grants were possible.

New Engine on Order

With our fire apparatus replacement plan, Engine 44 is due for replacement in 2024. Our apparatus committee spent many months planning and designing a new engine that would fit our company's needs for the next 20 years. We are excited to welcome this new Pierce Manufacturing Engine in early 2024.

Lastly, being a volunteer organization, we are always in need of new members to join our firehouse family. There are many roles that we fill, from Firefighting & Rescue Operations to Fire Police Operations, to Administrative Operations. We also have a Junior Firefighter program which is for 14-17 year olds who are interested in joining the Fire Company. PLYMOUTH AMBULANCE

Plymouth Community Ambulance Association (PCAA) is proud to announce the recent delivery of four 2022 Ford Ranger trucks. These units will be utilized as quick response vehicles (Medic Responder), staffed by one paramedic. They will be well-positioned around the Township and can provide early clinical intervention in the case of immediate life-threatening emergencies. When these vehicles are dispatched to an emergency, an ambulance is also sent. The Medic Responder will provide life-sustaining care including cardiac defibrillation, advanced airway protection, and administration of life-sustaining medications until the ambulance arrives.



Medical Tips

As the weather has been on the constant change, so are people's health and immune systems. A few helpful hints to try and help eliminate a trip to the doctor's office or an emergency room are:

- If you do not feel well, limit your exposure to others to avoid spreading germs.
- Always wash your hands.
- Stay hydrated.
- Know your signs and symptoms when a cold may start.
- Make sure your body has plenty of rest.

Things To Expect When Calling 911

Know your location (address, municipality, cross streets if possible, whether you're in a house or an apartment, and if it's an apartment what apartment number or building letter/name, best access etc.). Cell phone location information only gives a certain level of accuracy and like any other technology has its flaws. If you use VOIP make sure your location is properly

updated with your provider if you move to a new residence and brought that service with you. If your residence is obscured or there is not good labeling in the area, please provide additional descriptive information to help responders get to you.

911 operators will give you pre-arrival instructions, but to further help responders prior to arrival make sure access is clear, doors open or unlocked, and/or someone to guide responders to the emergency if possible.

When calling 911, know that things will be moving fast-paced and during emergencies time is critical but be assured all responders are trained professionals and take all situations into consideration when they are making decisions on helping the emergency.

When to call 911

Shortness of Breath

Many respiratory conditions may require immediate attention, such as Asthma, COPD, CHF and allergic reactions. These conditions can cause prolonged periods of shortness of breath, sudden onset of shortness of breath or an allergic reaction that causes hives, rash and shortness of breath.



Signs of a Stroke - remember to be F.A.S.T.!

- Facial droop or unequal smile
- Slurred Speech or unable to speak
- Arm numbness/weakness, are they able to move it?
- Time: when did the symptoms start?

 This timeline is vital for the crew to relay to the hospital.

Signs of a Heart Attack

Men:

- Chest pain
- Arm or jaw pain
- Sweating/pale skin

Women:

- Chest, back or shoulder pain
- Nausea, vomiting, heartburn, abdominal pain
- Severe weakness

FIRE MARSHAL

The Fire Marshal's Office wishes everyone a happy and safe spring and summer. The Fire Marshal's Office responds to and investigates fires to determine the origin and cause, conducts fire inspections and code enforcement to ensure buildings are safe, and provides fire safety programs for schools and community groups. Our team is comprised of a Fire Marshal & Emergency Management Coordinator, part-time Deputy Fire Marshals, and full & part-time Fire Inspectors. Our staff has state and national certifications as Fire Inspectors and Fire Investigators.

In 2022, the Fire Marshal's Office responded to 244 incidents and performed 59 fire investigations; and assisted surrounding municipalities with 8 fire investigations or other incidents. In addition, there were 232 fire inspections and re-inspections conducted at commercial properties.

Spring/Summer Safety

As the weather and temperature warms up, take steps to ensure fire safety around your house.

Barbecue Grills

Outdoor grills are great for cooking delicious foods. Use them safely so that you don't cook your house, too. Keep grills on level ground and at least 15 feet from any structure. Grilling should <u>NOT</u> be done on balconies or decks; or under any roof, covering, or tent. This includes both gas and solid fuel grills. Grills must be attended by an adult at all times while in use.

Fire Pits & Chimineas

It is nice to sit outside with family and friends around fire pits, chimineas, and any other open flame devices. However, this must be done safely. Open burning and open flame devices can be dangerous if you don't follow rules and laws.

This includes:

- A burn permit issued by the Township is required.
- They must be at least 15 feet from any structure, including decks, and property lines.
- A competent adult must attend to it at all times while in use.

Fireworks

Fireworks are great for celebrations, but only to watch. Leave fireworks to the professionals. Too many people suffer serious injuries from handling fireworks. Additionally, mishandled fireworks can cause devastating fires.

Pennsylvania allows the use of consumer fireworks, but there are laws and rules that must still be followed.

- Consumer fireworks are <u>NOT</u> to be ignited or discharged on streets, parking lots, sidewalks, parks, or within 150 feet of a building or vehicle.
- Do <u>NOT</u> aim or direct fireworks at or over buildings, vehicles, streets, people, or the properties of others.
- Consumer fireworks may only be used between 10 am and 10 pm; except on certain holidays, for instance: Independence Day, Memorial Day, Labor Day, and New Year's Eve, when they may be used until 1 am.
- Consumer fireworks should only be discharged by competent and sober adults over 18 years old. Youth under 18 should never handle, ignite, discharge, or use consumer fireworks.



Sparklers, novelties, and toy caps are allowed anytime; but care must be taken as they are still dangerous and can cause serious injuries. Children should never use these without adult supervision.

Display fireworks may only be used by professional pyrotechnicians and require permits and other documentation in order to be used in the Township. This must be completed prior to any display event.

For your safety, please leave fireworks to the professionals. If you choose to use consumer fireworks, follow the rules and be considerate of your neighbors.

Home Electrical Safety Tips

Electrical sources are one of the more common causes of fires in residences and businesses. Oftentimes these circumstances could have been avoided. Here are some tips to consider:

- Only plug a power strip or surge protector (also referred to as a relocatable power tap) directly into a wall outlet. Never into another power strip or extension cord.
- Do NOT overload a power strip. Be careful of what you are plugging into it. Overloading a power strip can cause it to overheat and catch fire.
- Air conditioners should be plugged directly into a wall outlet that is rated for that appliance; and never into a power strip or standard extension cord. If an extension cord is needed, use one that is specifically designed for air conditioners.
- Consider using appliances, devices, and cords that are UL or ETL listed. Look for this on a label. They were tested and met certain standards for safety.
- Never run electrical cords or power strips underneath furniture, carpets, rugs, or other things. This could cause them to become damaged or overheat and catch fire.
- Make sure plugs are pushed into a receptacle completely. If it is only part way in, an electrical arc can occur across the exposed prongs.
- If a device has a 3-prong plug; only plug it into an outlet that a 3-prong receptacle. Do not remove or break off the ground prong.



Spring cleaning is a good time to check on your safety equipment, too.

Smoke and CO Detectors

Replace smoke detectors after 10 years. The detectors have a lifespan, and for best operation, it is recommended that they be replaced every 10 years. If the smoke detector has replaceable batteries, change the batteries twice a year (when you change the time on the clocks) with new ones. When you install a new detector, mark the date you installed it on the detector; so you'll remember when you put it up. Not sure where to install detectors? - contact the Fire Marshal's Office and we can help you.

Fire Extinguishers

Check your fire extinguishers. Ensure the gauge shows the indicator is in the green. If the indicator is in or near the red area, replace the fire extinguisher. For dry chemical extinguishers, turn it over and back again to loosen up and move the powder around inside. Make sure the pin is still in the handle so that the fire extinguisher does not accidentally go off. Store extinguishers somewhere quickly and easily accessible in case of fire; and do not bury them way back in a cabinet or closet.

Home Escape Plan

The nice weather provides an excellent time to get outside. Why not practice your home escape plan? Does everyone in your house know which way to get out of the house? How about a second route in case the normal route is blocked by fire? Smoke and heat may be higher, so you may need to crawl to get out. Crawling through your residence is a lot different that walking; try it. Where will everyone meet once you get out? If you don't have an escape plan, then it is time to make one, and PRACTICE IT.

We can't help you if we can't find you - post your house number.

Make sure your house number is posted clearly. If you need the fire company, police, or ambulance, you want them to find your house quickly. If the responders can't see a house number, then it may delay them getting to you. Here are some things to know about house numbers:

- Must be at least 4 inches in height.
- The numbers need to contrast the background they are attached to. The house number should not blend in, but rather be easily seen.
- Use Arabic numerals (numbers), do not spell out the number in letters/words.
- Must be on the side of the house facing the street.
- Typically next to or above the front door or porch; or if the house is set back, the number can be placed on a post at the entrance driveway or on the mailbox.
- Can be made of wood, metal, plastic, or decals.
- Should be clearly visible if you stand on the opposite side of the street.
- Be sure to clear anything away that may block or obscure it, like tree branches, bushes, or shrubs.
 Never cover up or block the numbers from being seen.

Outreach

Fire safety and prevention is extremely important at home and work. We have worked with businesses to provide fire safety presentations and training to employees; schools to provide teachers, staff, and students with tips and training on how to prevent fires and what to do in case fires occur; community groups to provide information to have safe events and activities; and Scouts groups to help them with programs and merit badges.

Code Red is the name of the Township's emergency notification system. Residents can go Township to the Website at www.plymouthtownship.org and click on the "Code Red" logo on he homepage. You'll be linked to Code Red's site where you can enter additional phone numbers and email addresses to receive emergency and community service announcements from the Township, such as evacuation notices, bio-terrorism alerts, boil water notices, mosquito spraying notices and missing child reports, to name a few.

*If the holiday falls on Saturday or Sunday, the holiday is observed on Monday.

*When a holiday falls on your recycle day during the week, recycling will be picked up on Wednesday of that week. Your trash will be picked up on your next scheduled trash day.

Commonly Asked Questions About Trash Collection

Is your trash can too big?

Over the past few years, more and more residents are using 60-90 gallon carts as their trash containers. These carts are too large for our men to handle. These carts are designed to be lifted mechanically, not manually. Trash cans should be no larger than 30 gallons and weigh no more than 50 pounds when loaded. An empty 90 gallon cart weighs 40 pounds! As a guide, the round, blue recycle cans are approximately 30 gallon size. A trash can of this size is preferable. Please refrain from using trash carts (large containers with wheels). Trash will be left curbside and tagged if it is deemed to be too heavy.

When should I put my trash out?

Containers must be placed at the curb in front of the premises no later than 6:00 A.M. on the day of collection but no earlier than 7:00 P.M. on the day preceding the collection. Once the truck passes your house it will not return.

How should I put my trash out?

Trash should be stored in water-tight containers which have handles and loose fitting lids. Do not place trash and garbage in paper bags, cardboard boxes or flimsy plastic bags.

What happens when trash is strewn on the street?

If the trash men spill trash, they will pick it up. If an improper container breaks or animals tear up the trash, it is the property owner's responsibility for clean up.

Why didn't the trash men take all of my trash?

- 1. If you put out more than four containers, containers larger than 30 gallons or weighing more than 50 pounds, all of your trash will not be collected.
- 2. If your trash contained unacceptable items such as refuse resulting from the repair, excavation or construction of buildings, such as sand, earth, lumber, brick, stone, mortar, plaster, roofing materials, plumbing fixtures, etc., or tires, auto parts, hazardous wastes, household appliances, and yard waste, it will not be collected.
- 3. Contains recyclable material or yard waste.

How do I get rid of such items?

The Township collects household appliances once per month. See the section on Household Appliance and Scrap Metal collection for details. Yard Waste is collected every Wednesday. For hazardous waste information, call the Montgomery County Household Hazardous Waste Program at (610) 278-3618. Homeowners must dispose of other items on their own.

How do I get rid of bulky items, like furniture?

Large Items (such as furniture) will be picked up on your second regular collection day of the week, provided a holiday does not fall within that week.

Recycling Notice



Plymouth Township residents are required to separate recycling material from their trash for separate collection. DO NOT PUT RECYCLING IN PLASTIC BAGS. Items must be placed loose in the blue can. Any items in plastic bags will not be collected.

recycling pick-up includes newspaper, cardboard of all types, magazines and junk mail, clear, brown and green glass, and aluminum and bimetal cans and plastics. Recyclables are collected once a week, on your designated recycling day.

All items must be placed in the blue recycling container and set out at curbside for collection. Flattened cardboard items may be placed next to recycle containers. Additional containers may be used so long as it is marked for recycling. Recycle stickers are available at the Township Building at no charge. Blue recycle containers are for single stream recycling only. Yard waste or trash will not be accepted in this container.

Damaged containers can be exchanged at no cost. Lost containers will be replaced at the cost of \$25.00. Containers will be delivered while the Township Building is being renovated. Please call 610-233-0566.

Preparation Guidelines

Glass

- Clear, brown and green glass bottles and jars only.
- Remove all lids and rinse out.
- Labels may be left on.
- Please do not break the glass.
- Place at curbside in the recycling container.

Aluminum and Bimetal Cans

- Aluminum and bimetal (tin) beverage and food cans.
- Drain and rinse out the cans.
- The cans may be flattened or crushed.
- Place at curbside in the recycling container.

Papers

- Save newspaper, inserts, junk mail, telephone books, magazines, and all cardboard except pizza boxes.
- Place at curbside in the recycle container. Flattened cardboard items may be placed next to container.

Plastic (Now Collecting #1 thru #7)

- #1 PET, PETE, clear, tough plastic commonly used in soft drink bottles.
- #2 HDPE is a plastic commonly used to make bottles for milk, juice, water and laundry products.
- #3 PVC is a plastic commonly used to make some shampoo bottles, cooking oil bottles, some cosmetic bottles, charcoal lighter, mineral oil bottles
- #4 LDPE is a plastic commonly used to make food storage containers, dairy container lids, fabric softener bottles, lotion and sunscreen tubes
- #5 PP is a plastic commonly used to make yogurt containers, medicine bottles, deli containers, cosmetic containers, frozen juice cans, some microwave containers.
- #6 PS is a plastic commonly used to make yogurt cups and tubs, cookie and muffin trays, clear carry out containers, aspirin & vitamin bottles (no Styrofoam).
- #7 Others can be used to make some ketchup squeeze bottles, syrup bottles, glass cleaner bottles, 5 gallon water cooler bottles, microwave containers, layered plastic containers.

Containers may be flattened or crushed to save space.

Please check # on bottom of plastics. If it does NOT have a 1 - 7 in the triangle symbol it is not recyclable by our recycle center.

Recyclables must be placed at curb no later than 6:00 A.M. on the collection day, but no earlier than 7:00 P.M. on the day preceding the collection. If a holiday falls on your recycling day, your recyclables will be collected on Wednesday of that week.

Household Appliance and Scrap Metal Collection Fee: \$10

The Township has a separate collection for stoves, freezers, refrigerators, washing machines, dryers, metal cabinets and all metal furniture because these items are not accepted at the trash-to-steam plant.

These items are picked up once a month on the third Wednesday of the month. Residents desiring to have an appliance removed must call the Public Works Department by the second Friday of the month at **610-277-4103** to get the \$10 Disposal sticker and to be placed on the list. Items without stickers will not be collected. Once stickers are purchased there are no refunds.

Electronics Collection (Covered Device Act)

Electronics are required by Law to be recycled under the new Covered Device Act. They will not be accepted in regular trash.

The Township has an electronics and universal waste drop-off located at the public works building at no cost.

Televisions can either be dropped off at the Publics Works Electronic Shed at no charge or for a \$10 service fee we will pick it up curbside on the third Wednesday of the month. Residents desiring to have a television picked up must call the Public Works Department by the Friday before the collection date at 610-277-4103 to get the \$10 Disposal sticker and to be placed on the list. Items without stickers will not be collected. A disposal sticker is required for curbside television collection only. Once stickers are purchased there are no refunds.



Call the Public Works Office 610-277-4103 for drop-off procedures and location information or to get on the television disposal list.

Yard Waste Collection

This program is in addition to your regular trash pick-up and recycle day. Every year hundreds of tons of recyclable yard waste is thrown into the waste stream costing the Township \$60 for every ton. In our ongoing effort to help the environment, we are continuing this program to validate our commitment to help the environment and save tax dollars in the process.

Residents who have yard waste should put it out before 6:00 AM every Wednesday.

Collection will be in a designated trash truck for yard waste. Remember, all of our trash trucks look the same so rest assured that each one will be designated for a particular waste material.


What is Yard Waste?

Yard waste is grass clippings, twigs/shrub trimmings and prunings, leaves, and garden waste such as pinecones, weeds, dead plants. Rocks, dirt and logs are not considered yard waste!

How do I prepare my yard waste for collection?

Yard waste must be placed in biodegradable brown paper bags or in a designated yard waste container or trash can. <u>NO PLASTIC BAGS!</u> All material that is not properly prepared will not be collected.

Biodegradable brown yard waste bags can be purchased at Home Depot, Lowes and some grocery stores.



Branch and Chip Program

The Township runs two Branch and Chip Collection programs during the year.

The Spring program will run from the week of March 6th through the week of April 10th, 2023. Collection will end on April 14th.

The Fall program will run from the week of September 4th through the week October 9th, 2023 ending on October 13th.

Residents who want tree branches picked up during these periods must call the Public Works Department at **610-277-4103** prior to <u>noon</u> Wednesday of the week they wish to have the branches picked up and provide their address. Branches will be collected on Thursday and Friday, weather permitting. Collection may be delayed until Monday or Tuesday of the following week.

IF YOU DO NOT CALL, YOUR BRANCHES WILL NOT BE PICKED UP.

The Public Works Department chips the branches and stockpiles the chips.

Free wood chips and leaf compost are available at the Township Building.

Residents should comply with the following:

- Leave the branches as long as possible a minimum of five feet (5') in length.
- Nothing over five inches (5") in diameter can be chipped.
- Branches should be placed at the curb in an orderly pile.
- Branches with thorns will not be collected.

All other Yard Waste will be collected every Wednesday throughout the year during the designated collection period.

Mulch Deliveries

The Public Works Department will deliver up to 1 dump truck load (approx. 5 yards) to your household for free again this year. **There is a 1 yard minimum.**

Each year over 1,000 tons of yard waste is collected. This material is stockpiled so it will break down at the Public Works yard. This material along with composted leaves is processed by our tub grinder to make mulch. The processed material is a makeup of about 75% woody material and 25% broken down composted leafy material. Together it makes mulch to place around trees and flower gardens. This material holds moisture for your trees and gardens and amends the soil with additional nutrients.

Deliveries are every Friday throughout the year from March to November. Anyone who would like a mulch delivery must fill out a delivery request form/liability release form. If you would like delivery on Friday you need to sign the waiver before Wednesday at 4:00 PM the week of delivery.

Call Before You Dig

Did you ever wonder what those painted markings in the street were? You know, the fluorescent green, blue, yellow and red ones. These painted lines are color coded surface markings for the location of underground utility lines.

Before you begin any excavation over four inches deep, property owners are required by state law to notify utilities by calling the Pennsylvania One Call System at **1-800-242-1776** or simply dial 811. The call will notify involved utilities, so they can mark their lines to avoid accidental damage. There is no cost to residential property owners for this service.

The ID colors are as follows:

- Red Electric
- Yellow Gas and Oil
- Orange Communications
- Blue Water
- Green Sewers and Drain Lines
- White Proposed Excavation
- Pink Temporary Survey Markings

You would never dream about dumping garbage into Saw Mill Creek. But let waste run down its storm drain and that's exactly what you're doing!

Storm Water Regulations

New federal storm regulations require Township, as well as most other Post Construction Storm Water municipalities in "urbanized areas" across Pennsylvania, to comply with Prevention and Good Housekeeping Environmental the Agency's new storm water management program. One of the many requirements of the program is to obtain a National Pollutant Discharge Elimination System (NPDES) permit. The program in Pennsylvania is administered by the Pennsylvania Department Environmental Protection (DEP). Plymouth received its permit on June 28, 2013. The Township is in the process of implementing the storm water management protocols developed by the DEP.

Under the program, Plymouth Township will implement the six required Best Management Practice (BMP) control measures, including Public Education, Public Participation, Illicit Discharge

water Detection and Elimination, Plymouth Construction Site Run-off Control, Management Pollution and Protection for Municipal Maintenance.

> important part of the Township's compliance plan is to educate the public regarding the environmental impact of storm water run-off. The PA DEP maintains a website with comprehensive information on storm water education (www.dep.state.pa.us). The Plymouth Township (www.plymouthtownship.org) also has information and links to other websites.

> We also ask that residents report any suspected pollution incidents to the Township at 610-277-4103. This includes the dumping of wastewater, illicit liquids or solids into streams or storm sewers.

Where Does Your Sump Pump Flow?

Are you aware that it is illegal to have your sump pump connected to the sanitary sewer system? Illegal sump pump connections put unnecessary rain water into the Township's sanitary sewer system. The Township pays to have this water treated. This results in higher sewer rates for everyone. In addition, it can overload pump stations and other facilities. This leads to sewer overflows, which can cause environmental, and other health hazards, as well as costly property damage. It can also lead to expensive facility upgrades, which result in higher sewer rates and taxes.

What can you do to help? Make sure your sump pump is not connected to the sanitary sewer system. Sump pumps should be connected to a pipe so it can discharge to a lawn area where it can infiltrate back into the ground. Keeping rain water out of the sanitary sewer system will help keep rates from rising unnecessarily.

If you need help with suggestions on where to re-route your sump pump discharge, please call the Plymouth Township Public Works Department at 610-277-4103.

Plymouth Township Property Sale Sewer Inspection

The owner must have the sewer lateral inspected by a licensed Master Plumber, that is registered in the Township prior to the sale of a property. It is recommended that this process start once the property is listed for sale due to the time it will take for completion, but no later than once a property has an agreement of sale. The inspection should be completed before the property is transferred.

The Plumber must video the lateral from the house to the inlet of the main to make sure there is no water infiltration or illegal hook-ups (sump pumps, Storm water inlets, etc.).

Then the Plumber will prepare a report stating what is found and provide a copy of a video on CD or DVD that will be given to the Township.

If the lateral is found to be deficient, then a permit application must be submitted and approved, prior to repairs being made. Repairs should be completed prior to transfer of the property.

Once the repairs are made, the Plumber must submit a report stating that all deficiencies have been remediated.

If the repair can't be made prior to settlement, then a Home Sale Affidavit signed by the buyer must be submitted to the Township before a Certificate of Adequacy will be issued.

Work must be completed no later than 30 days after settlement. This inspection is in addition to the curb & sidewalk inspection.

Selling Your Home?

Certificate of Adequacy: \$25.00

New Certificate of Adequacy procedures:

All properties must have their Sewer Lateral, Curb and Sidewalk and House Numbers inspected and a "Certificate of Adequacy" issued prior to resale and deed registration with the County.

Curb and Sidewalk Inspection:

Township staff will perform the inspection. Damaged curbing and sidewalk meeting the replacement guidelines must be repaired in compliance with Township specifications. Properties without a curb and sidewalk will not be required to install them.

House Number:

Township staff will perform the inspection. Numbers must be 4" high and visible from street.

Sewer Lateral Inspection:

The owner must have the sewer lateral inspected by a licensed Master Plumber who is registered in the Township. If a sewer lateral is found to be deficient, then the necessary repairs will need to be made prior to transfer. Please allow at least three weeks for the curb, sidewalk, house number and sewer lateral inspection. Don't delay, request the inspection as soon as you list your property.

Condominiums are required to have their sewer lateral inspected and the disclosure statement signed prior to resale. Curbs and sidewalks are exempt for private communities.

Is Your Sidewalk Passable?

The Plymouth Township code requires property owners to keep their sidewalks clear and passable. The most common impediment to safe pedestrian passage is overgrown bushes and low hanging branches. With the spring chipper program right around the corner, now is good time to consider cutting back those low hanging branches. Dates and procedures for the program are outlined elsewhere in this newsletter.

Is Your Street Light Out?

To report defective street lights, call the Public Works Department at **610-277-4103** between 8:00 AM and 4:00 PM Monday through Friday. An after hours message can be left on the Township's voice mail system. Just leave the pole number, street location and your phone number (optional). Requests for service can be delayed without the pole number. Please have the pole number before you call. Emergencies can be reported at anytime to the Police at **610-279-1901**.

Grass, Just Cut It and Leave It!

Grass clippings are a major part of Plymouth Township's municipal solid waste stream during the summer months. Like other highly recyclable materials – such as paper, glass, aluminum and plastic – recycling grass clippings can help reduce the amount of waste going to the Resource Recovery Facility.

As a Plymouth Township resident, you already help reduce the amount of waste you generate by recycling paper, glass, cans and plastics.

But there's another common home waste that you can also easily recycle: the clippings you generate every time you cut your lawn. Just "Cut It and Leave It".

Are grass clippings really that much of a disposal problem?

Yes. During the summer months grass can account for as much as 50% of the Yard Waste Collection. This takes unnecessary manpower and money to collect. A 5,000 square foot lawn will generate at least a ton of grass per season.

What can you do to help?

It's really simple. Just leave the clippings on the lawn when you mow it. Grass clippings provide a natural and healthy fertilizer for a growing lawn.

What about thatch?

Don't worry about the clippings contributing to thatch problems. Lawn experts agree that lawn clippings do not create thatch in lawns. Thatch is formed by the accumulation of dead roots and stems.

What could be easier than cutting your lawn and not bagging the clippings?

You'll save time because you won't have to stop and empty a lawn mower bag, you'll avoid trips to the can or bag, and you'll avoid carrying the clippings to the curb.

You'll save money because you won't have to buy extra trash bags. You can also spend less on fertilizer since clippings left on the lawn recycle nutrients back into the soil.




