Pledge of Allegiance - The Regular Meeting was called to order at 7:00 p.m. and Chairwoman Bramblett led the Pledge of Allegiance.

PUBLIC COMMENT- There was no public comment pertaining to any items advertised on the agenda.

A roll call vote was taken and the motion passed 5-0 with Ms. Viscio, Mr. Whitney, Ms. Leonard, Mr. Nelson, and Ms. Bramblett in favor.

Ms. Ardis Lukens- asked about the status of the crosswalks and sidewalks in Connaughtown. Chief Myrsiades stated the Traffic Engineer was working on the crosswalk, which was submitted to PENNDOT. Ms. Bramblett stated she, Ms. Weiss, and the Township Engineer walked the site. They all agreed that this area needs a sidewalk due to the safety of pedestrians. However, the question is where to place the sidewalk. Ms. Weiss stated the Township Engineer would reach out to PENNDOT about a mid-block crossing.

Mr. Rich Schickling asked if a municipal parking lot could be built on the riverside of New Elm Street. There is all private property in that area.
