# July 9, 2018

Pledge of Allegiance - The Regular Meeting was called to order at 7:00 p.m. and Mr. Higgins led the Pledge of Allegiance.

**PUBLIC COMMENT-** Mr. Higgins asked if there was any public comment pertaining to any of the items advertised on the agenda and there was none.

# ANNOUNCEMENT - Executive Session held July 2, 2018

Mr. Higgins announced that an Executive Session was held on July 2, 2018 in order to discuss litigation and personnel issues.

APPPROVAL OF MINUTES: Chairman Higgins called for the approval of the minutes.

Mr. Manero made a motion to approve the minutes without the necessity of reading. The motion was seconded by Ms. Bruno; a roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

APPROVAL OF DEPARTMENTAL REPORTS AND BILLS: Chairman Higgins called for the approval of the departmental reports and bills.

Ms. Bruno made a motion to approve the departmental reports and bills and was seconded by Mr. Manero. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

## ADMINISTRATION

- a.Comcast Cable Franchise Renewal Ordinance First and Final Consideration ACTION Mr. Clarke read the ordinance of Plymouth Township authorizing execution of a cable franchise agreement between the Township and Comcast of Pennsylvania, LLC. Mr. Manero made a motion to approve the ordinance for first and final consideration. The motion was seconded by Ms. Bramblett; a roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.
- c.Tax Settlement 550 W. Germantown Pike Mr. Clarke read the tax settlement between the taxpayer, W.V. Universal, LLC and the School District located at 550 W. Germantown Pike. The taxpayer has agreed to a settlement which has resulted in an underpayment of taxes to the Township for the years 2017 and 2018 in the amount of \$3,262.98. Ms. Bramblett made a motion to approve the tax settlement and was seconded by Ms. Bruno. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

# PUBLIC/WORKS/SEWER

a.Handicap Parking Space Resolution - 454 New Elm Street - ACTION - Ms. Bramblett read the resolution authorizing the installation of a handicap parking space at 454 New Elm Street. Mr. Manero made a motion to approve the resolution and was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

- 1) Plymouth Hospitality to September 25, 2018 Ms. Bruno made a motion to approve the extension request and was seconded by Mr. Manero. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.
- e.Escrow Releases ACTION The Township is in receipt of correspondence from Woodrow and Associates recommending the following escrow release.
- 1) Plymouthtowne Ms. Bramblett made a motion to approve the escrow release for Plymouthtowne Apartments in the amount of \$362,379.52. The motion was seconded by Mr. Manero; a roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.
- 2) Brierdale Builders The developer is requesting a release of the escrow funds in the amount of \$27,784.00. Mr. Manero made a motion to approve the escrow release and was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

# CODE ENFORCEMENT/HEALTH

a.Fire Alarm, Sprinkler, Extinguishing System Registration
Resolution - ACTION - Mr. Manero read the resolution authorizing an increase in the fee for Fire Alarm, Sprinkler, and Extinguishing System Registration from \$75.00 to \$100. Mr. Manero made a motion to approve the resolution and was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

Mr. Higgins stated that the increase in fees was recommended by the Township's Code Enforcement Department.

b.Rental Inspection Fee Resolution - ACTION - Mr. Manero read the resolution increasing the fee for Rental Inspections to cover administrative costs from \$40.00 to \$45.00. Mr. Manero made a motion to approve the resolution and was seconded by Ms. Bruno. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Bruno, Mr. Higgins and Mr. Manero in favor. Mr. Gannon was absent.

Mr. Higgins stated that the increase in the fee was recommended by the Code Enforcement Department and it will help the Township to cover its costs.
