#### REGULAR MEETING

## October 12, 2020

Plymouth Township Council held its Regular Meeting via Zoom. The following officials were in attendance:

Pledge of Allegiance - The Regular Meeting was called to order at 7:02 p.m. and Chairman Manero led the Pledge of Allegiance.

Swearing in Harmonville Fire Police- Anthony DeNolfi- Mr. Manero presided over the swearing in of Anthony Denolfi as a new member of Harmonville's Fire Police Unit.

**PUBLIC COMMENT-** Mr. Sabey asked if the township building renovation was on the agenda for tonight. Mr. Manero stated no.

ANNOUNCEMENT- Executive session held October 5, 2020

**APPPROVAL OF MINUTES:** Chairman Manero called for the approval of the minutes.

Ms. Bramblett made a motion to approve the minutes. The motion was seconded by Ms. Bandish.

A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.

APPROVAL OF DEPARTMENTAL REPORTS AND BILLS: Chairman Manero called for the approval of the departmental reports and bills.

Mr. Higgins made a motion to approve the departmental reports and bills. The motion was seconded by Ms. Bramblett.

A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.

#### **ADMINISTRATION**

- a. Proposed Group Home Ordinance- Mr. Clarke stated one change has been made to this ordinance which is, that group homes and sober living environments are permitted in all residential districts in the Township. Ms. Bramblett asked if group homes were allowed in commercial districts. Mr. Clarke stated no. Chris Saulino- 1641 Gallagher Court- thanked Council for the change to all residential districts. Council agreed to send this to the Montgomery County Planning Commission.
- b. 2021 Budget Meetings- October  $19^{\rm th}$ , October  $26^{\rm th}$ , November  $16^{\rm th}$  6:00 p.m. Mr. Manero announced the Budget Meeting dates as follows: October  $19^{\rm th}$  at 6:00 p.m., October  $26^{\rm th}$  at 6:00 p.m., and November  $16^{\rm th}$  at 6:00 p.m.
- c. Pension Fund- Allocation of 2020 State Aid Check- ACTION- Mr. Gannon reported that the Township received a check from the State in the amount of \$792,737.15 to help fund the Township Pension Plans. The allocation for 2020 is \$413,601.99 for the Police Pension Plan and \$379,135.16 for the Non-Uniformed Plan. Mr. Gannon made a motion to approve this and was seconded by Mr. Higgins. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.
- d. Police Pension Resolution- ACTION- Mr. Gannon made a motion to approve the resolution establishing the contribution rate for the Police Officers at 3% for 2021 as recommended by the Township Actuary. The motion was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.
- e. Alternate Appointment to the Zoning Hearing Board Resolution-ACTION- Ms. Bramblett made a motion to appoint Ms. Amy Lettich as alternate to the Zoning Hearing Board. The motion was seconded by Mr. Higgins. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.

- a. Addendum to Recycling Contract— Ms. Bramblett made a motion to approve a 12 month extension to the recycling consortium's contract with J.P. Mascaro. The motion was seconded by Mr. Gannon. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.
- **b. Street Light Request for Weymouth Road-** Mr. Higgins made a motion to approve the request for an additional street light at Weymouth and Oxford Roads. The motion was seconded by Ms. Bandish. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.

Andy Katronick- 332 Weymouth Way- explained the PowerPoint slides that were sent over. Mr. Higgins asked for a model with a 30 year loan and no carbon tax. Mr. Gannon asked what inflation rate was used. Mr. Katronick stated 1%. Mr. Higgins asked if there are other buildings that have used geothermal. Mr. Sabey stated he knows of 3 sources to contact that have used this method.

Vivian Lotz- 7 Timberfare Cir- stated two of her neighbors' political signs have been removed from their properties on Ashwood Lane. Ms. Lotz wanted to know if this is happening a lot. Chief Myrsiades stated this has been happening a lot, unfortunately. However, any act of vandalism should be reported to the police, and they will investigate.
