Bond Issue Ordinance- Final Consideration- ACTION- Mr. Pat Scott from Obermeyer, summarized the ordinance and stated authorization of \$18 million dollars in bonds will fund capital improvements to the Township Building. Mr. Scott stated the bond underwriter will be Janney Montgomery Scott and the paying agent is M and T Bank. Mr. Ben Kapenstein from PFM, stated the credit rating is currently underway. Mr. Higgins made a motion to approve this ordinance and was seconded by Ms. Bandish. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.
- b. Tax Settlement- Place One Apartment Associates LLC- ACTION-Mr. Glassman stated this settlement agreement resulted in an under payment of \$30,934.98 to Plymouth Township. Mr. Higgins made a motion to approve this tax settlement regarding Place One Apartment Associates LLC, located at 777 W. Germantown Pike. The motion was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Mr. Gannon, Mr. Higgins, and Mr. Manero in favor.
