March 14, 2022

Pledge of Allegiance - The Regular Meeting was called to order at 7:07 p.m. and Chairman Manero led the Pledge of Allegiance.

PUBLIC COMMENT-

Unit Citation for Detectives, Officers, and Dispatchers- Mr. Manero stated on January 27, 2022, at 3:19 p.m., the Plymouth Township Police Department responded to a report of a missing 5 year-old child at the Plymouth Meeting Mall. An initial investigation determined that a non-custodial parent kidnapped the 5 year-old child from the legal custody of Child Protective Services during a supervised visit.

Members of the Plymouth Township Police Department then coordinated with numerous law enforcement agencies and a comprehensive multi-county search began for the kidnapped child. Teams of officers and detectives from the Plymouth Township Police Department, with assistance from the Philadelphia Police Department, Montgomery County Detective Bureau, and SEPTA Transit Police, searched areas of concern in both Montgomery and Philadelphia Counties, with the assistance of Police Dispatch.

Through a quick response, solid investigative technique and multi-agency cooperation, the child was safely located in Philadelphia County, still with the non-custodial parent. Officers provided the child with needed nourishment, and the foster parents later took custody of the child. Detectives took the non-custodial parent into custody, later charging the parent with interference with Custody of Children.

Mr. Manero made a motion to approve this citation and was seconded by Ms. Viscio. A roll call vote was taken and the motion passed 4-0 with Ms. Bramblett, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor. Ms. Bandish was absent.

Words of Remembrance for Retired Chief Carmen D. Pettine- Chief Myrsiades recognized former Chief Carmen Pettine for his lifetime of public service.

A plaque memorializing his decades of service was presented to Chief Pettine's family. We thank you for your service and wish you eternal peace.
