Pledge of Allegiance - The Regular Meeting was called to order at 7:04 p.m. and Chairman Manero led the Pledge of Allegiance.

PUBLIC COMMENT- There was no public comment pertaining to any items advertised on the agenda.

The balance that is needed to finish is \$71,043.50. Ms. Bandish made a motion to approve this release and was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.
- 3) Black Horse Woods/Fairfield Road- Mr. Whitney stated this communication is from Woodrow & Associates, stating sufficient work has been completed to release \$14,320. Mr. Whitney made a motion to approve this release and was seconded by Ms. Viscio. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.

PLANNING AND DEVELOPMENT

- a. Campus Renovation- Six Change Orders- Ms. Bandish read the first three change orders for Rycon Construction, Inc.: 1) roof insulation- \$21,887, 2) ADA vestibule doors- \$45,564, and 3) site grading changes- \$16,076. Ms. Bandish made a motion to approve and was seconded by Ms. Bramblett. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.
- Ms. Bandish read the remaining three change orders for Wind Gap Electric: 4) moving conduits- \$26,276.40, 5) adding a 4th conduit with a weather head- \$1,971.29, and 6) installing temporary service for office trailers- \$6,980.68. Ms. Bandish made a motion to approve and was seconded by Mr. Whitney. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.
- Mr. Richard Schickling asked if they have a projected time of when the township offices will be completed. Ms. Weiss stated the contractors are saying the substantial completion date is at the end of December and then the final completion date is sometime in January.

MISCELLANEOUS/OLD BUSINESS

- a. Citizen Board Vacancy Announcement- Ms. Viscio stated the following citizen board positions are open: three positions on the Property Maintenance Code Appeals Board, one on the Historical Architectural Review Board, one on the Human Relations Commission, and one on the Environmental Advisory Board. Anyone interested in serving on one of these boards can submit a resume or letter of interest to Karen Weiss, the Township Manager.
- **b. Environmental Advisory Board Appointment-** Ms. Viscio stated she would like to make a motion to appoint Leena Shevade to fill the Environmental Advisory Board position and was seconded by Mr. Whitney. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.

AUDIENCE PARTICIPATION

Mr. Alex Evangelista stated the October meeting minutes are not available on the website. Mr. Manero stated they have to be approved tonight and then they will be made available to the public. In addition, Mr. Evangelista stated the location for these meetings is incorrect on the website; it states the Township Building and not the Greater Plymouth Community Center. Ms. Weiss stated she will look into this.

Mr. Richard Schickling thanked the Police Department for their involvement at AristaCare during an antique car show. In addition, he stated he found a solution to what he believes is a problem at that location. Hallowell Road should have a light that works with the traffic light at Jolly and Germantown. Mr. Manero stated the lights on Germantown Pike are regulated by PENNDOT. Chief Myrsiades stated he would look into it.

Ms. Ardis Lukens asked if Council heard anything regarding the clear-cutting of trees down at the river in Conshohocken. She is concerned it will happen in Plymouth. Mr. Schickling stated he heard that Septa is using their property for riverfront development. Council stated they have not heard anything regarding this matter. Ms. Weiss stated she is not sure they would even hear anything, since they would not need to okay it. Mr. Woodrow stated if it's vegetation management, they sometimes are concerned about trees overhanging on wires or on the train track.

Ms. Lukens thanked Mr. Manero and Ms. Bandish for their time and effort on Council.

There being no further business, the Regular Meeting was adjourned at 7:35 p.m.
