The Meeting was called to order by Ms. Weiss at 7:30 p.m. and opened with the Pledge of Allegiance.

**Public Comment** - There was no public comment pertaining to any items advertised on the agenda.

**Election of Chair-** Ms. Weiss asked for nominations for Chair. Ms. Viscio nominated Mr. Manero and was seconded by Ms. Bandish. Ms. Weiss asked if there were additional nominations for Chair and there were none. A roll call vote was taken on the motion for Mr. Manero to be elected as Chair, and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.

**Election of Vice Chair-** Chairman Manero asked for nominees for Vice-Chair. Ms. Bandish nominated Ms. Bramblett and was seconded by Mr. Whitney. Mr. Manero asked if there were additional nominations for Vice-Chair and there were none. A roll call vote was taken on the motion for Ms. Bramblett to be elected as Vice-Chair, and the motion passed 5-0 with Ms. Bandish, Ms. Viscio, Mr. Whitney, Ms. Bramblett, and Mr. Manero in favor.

**Appointment of Township Consultants and Acceptance of Rates** - Ms. Viscio made a motion to approve the Township's Consultants and acceptance of rates. The motion was seconded by Ms. Bandish.

A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.

**Citizen Board Reappointments-** The Citizen Board reappointments and appointments were outlined. Ms. Bramblett made a motion to approve the reappointments. The motion was seconded by Ms. Viscio. A roll call vote was taken and the motion passed 5-0 with Ms. Bramblett, Ms. Bandish, Ms. Viscio, Mr. Whitney, and Mr. Manero in favor.
