

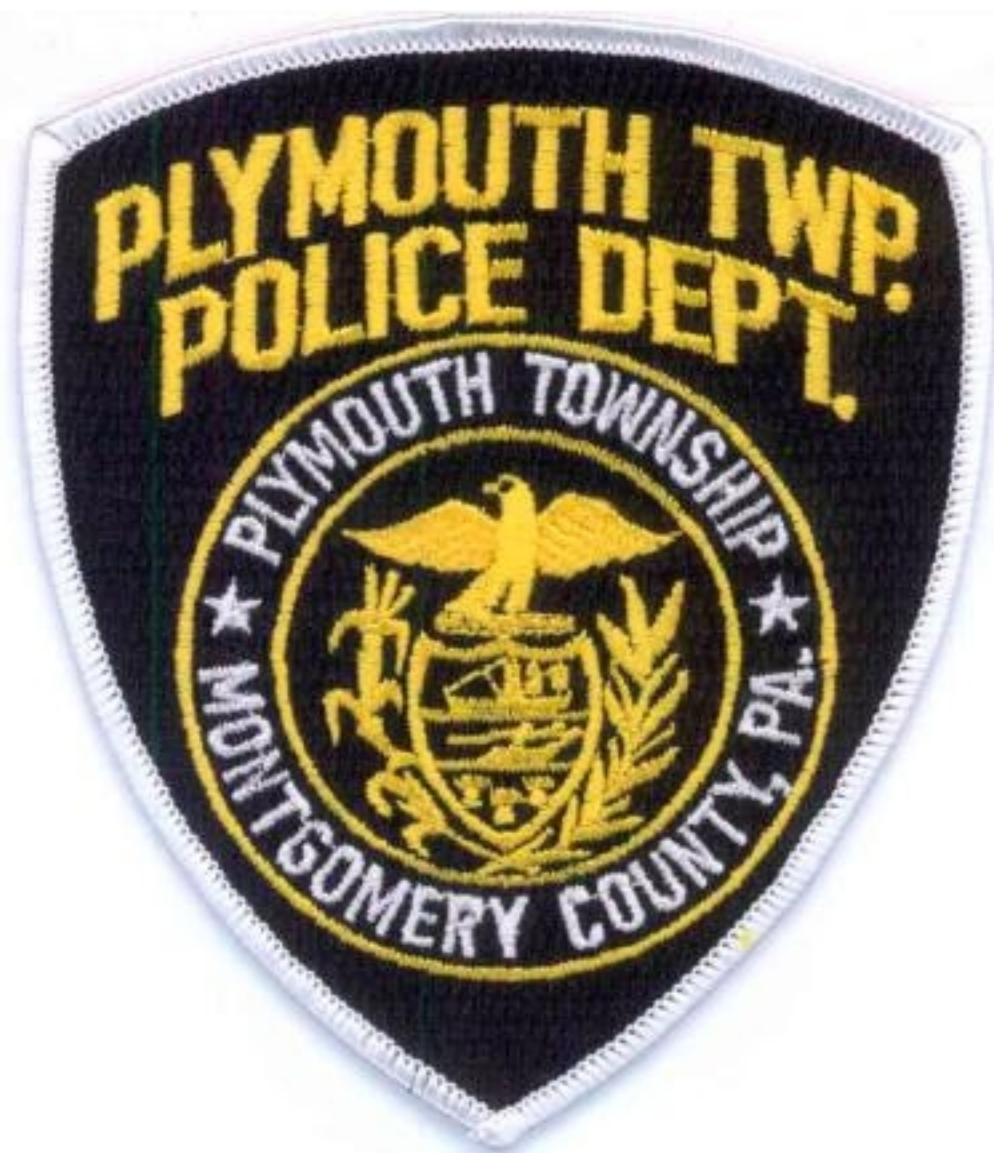

## **Plymouth Township Police Department Annual Report Overview**

2014 was a busy year for the Plymouth Township Police Department. The Patrol and Detective Divisions responded to and investigated 3 separate homicides during the year. In June, the Patrol Division responded to a 'well-being' check after family members became concerned about a relative who was not answering her phone or responding to them at the front door. Patrol officers entered the residence and found that both occupants were deceased due to a murder/suicide. Several weeks later, our Detective Division was contacted by the Pennsylvania State Police regarding a body that was located in the western part of the state. Through investigation, the Detective Division determined that a township resident was murdered in his home by his adult son. He was arrested and remains behind bars awaiting his trial. In September the Patrol Division responded to the Montgomery County Training Facility on a 'medical assist' call. Responding officers arrived quickly only to find that a Pennsylvania State Trooper was accidentally shot during a training exercise. Responding officers provided emergency care until the Trooper was medically evacuated. Sadly the Trooper succumbed to his injuries.

Unfortunately, the Township saw significant increases in rape offenses, weapons offenses, and criminal mischief; sixty-seven percent (67%), sixty-seven percent (67%), and twenty-six percent (26%) respectively. Conversely, there were decreases in burglaries, thefts and motor vehicle thefts; fifty percent (50%), twenty-nine percent (29%) and thirteen percent (13%). Additionally, there was a twenty-three percent (23%) increase in traffic citations which led to safer roadways as well as a three percent (3%) decrease in crashes. The aforementioned decrease in street crime and motor vehicle crashes was influenced by a concerted effort by the Patrol Division to target problem areas in the Township. This proactive approach greatly reduced the opportunity for criminal activity and also resulted in safer roadways for our commuters. Notable cases cleared in 2014 include the arrest of 2 subjects for a home invasion burglary, in which they threatened to shoot the elderly female victim. Both subjects were also wanted for over 50 burglaries in multiple states. In addition, the arrest of 3 subjects for armed robbery of a 73 year old Philadelphia bar owner, in the parking lot of his residence at the Plymouth Hill Condominiums.

The Plymouth Township Police Department continues to strive to be the best in all aspects of law enforcement, which includes special units. Officer Doug Wells retired his K-9 partner Judo and was recertified with a new K-9 partner Vilko. Officer Eric Ponzek left the K-9 Unit and Officer Mike Watts took over the responsibilities of handling K-9 Major after completing basic K-9 and explosive detection training.

Staffing changes in 2014 occurred in the Patrol Division, the Records Division and Communications Center. In February, Officer Michael Bolinsky retired after serving Plymouth Township for 25 years. Officers Holly Donohue and Christopher Hummel were sworn-in in February and March respectively as probationary officers. Karen Bowman transferred into the Communications Center as a dispatcher and Sabrina Evangelist was hired in May as the Administrative Supervisor overseeing both Records and Communications.

In 2014, the Police Department obtained \$33,575.00 in grant monies. The specific grants included the Pennsylvania Liquor Control Board Grant (\$20,000.00), Pennsylvania Seat Belt Enforcement & Education Program Grant (\$3,600.00), Pennsylvania Aggressive Driving Special Funding Grant (\$3,675.00), Pennsylvania Aggressive Driving Grant Wave 1 (\$2,000.00), Pennsylvania Aggressive Driving Grant Wave 2 (\$2,300.00) and Pennsylvania Aggressive Driving 2014-2015 Grant Wave 1 (42,000.00)

The Police Department, as in years past, continues to provide the best possible service to all members of our community. We pledge to maintain a safe and harmonious community for all.

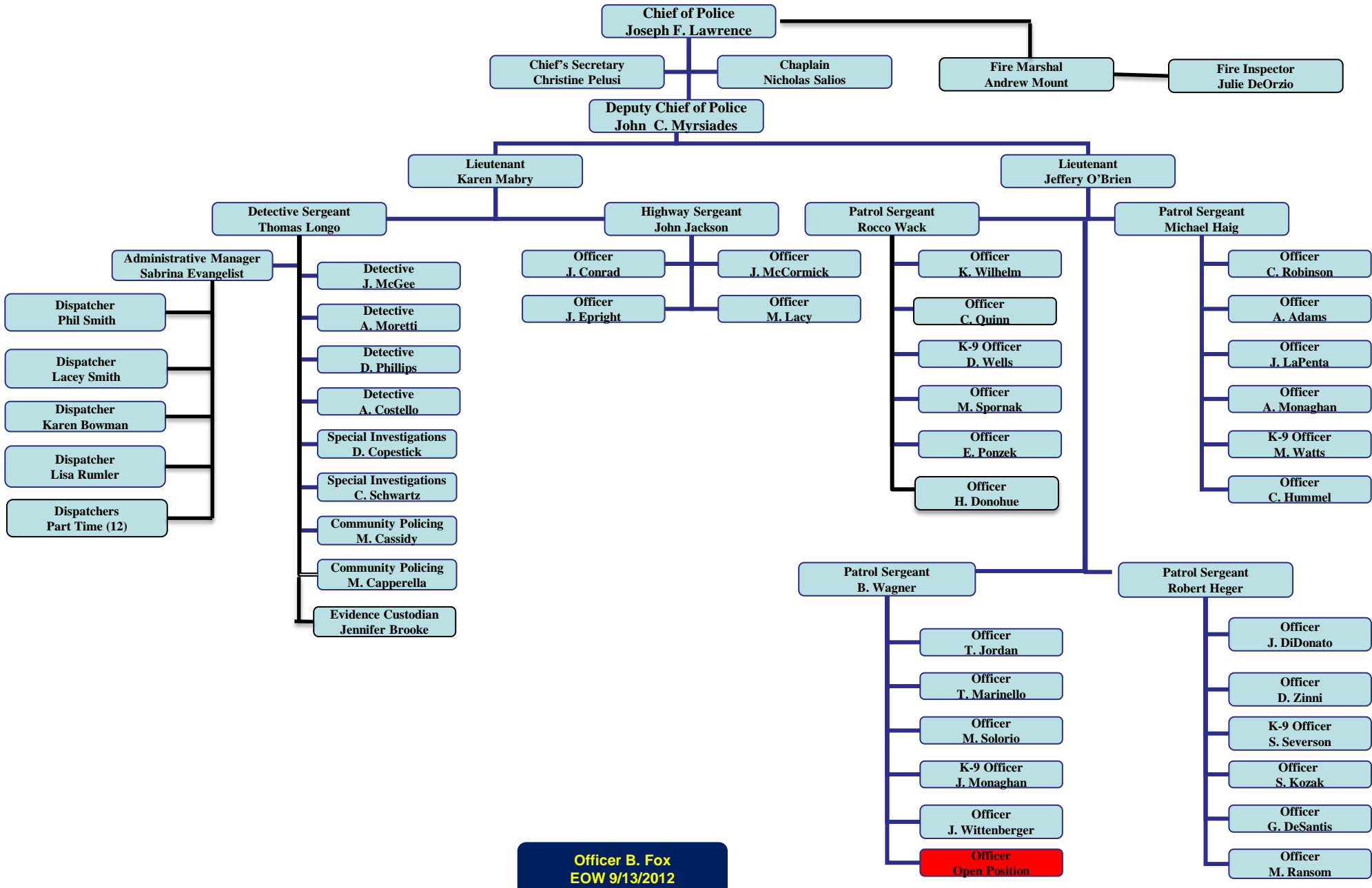

## **Plymouth Township Police Department Patrol Division**

The Patrol Division of the Plymouth Township Police Department is widely considered to be the back bone of the entire Department. It is comprised of four individual Patrol squads, offering twenty four hour coverage of the Township. Because the Patrol Officer is usually the first and oftentimes only contact the public has with the police, they are the Department's ambassadors to the community. Each squad is led by an experienced Patrol Sergeant: Sergeants Michael Haig, Robert Heger, Rocco Wack and Brian Wagner. Officers assigned to Patrol typically work twelve hour shifts and rotate between a day shift and a night shift every two weeks. Additionally, the Highway Patrol Unit, which is comprised of four officers trained in accident reconstruction and supervised by Sergeant John Jackson, round out the Division. Officers in the Highway Patrol Unit tend to work rotating shifts during the hours when there is more roadway congestion and a greater number of crashes.

At the end of 2014, the Patrol Division was made up of 32 sworn officers, with 27 being in Patrol and 5 being in the Highway Patrol. In February, Officer Michael Bolinsky retired from the Plymouth Township Police Department after 25 years of service and Officers Holly Donohue and Christopher Hummel were hired in February and March respectively. Both new officers spent several months being trained and closely supervised and each is gaining valuable experience daily.

The Patrol Division works closely with the Detective Division. In Plymouth Township, the Patrol Officer conducts a preliminary investigation and very often handles a call from start to finish. This includes many arrests and any subsequent court proceedings. Nearly every call, every serious accident and every significant incident that is eventually transferred to the Investigative Unit, begins with a response from Patrol. Many of these calls for service are unstable in nature, they may be chaotic, and many times there are legitimate safety concerns upon initial officer arrival. Once a scene has been stabilized and information has been gathered, it may warrant the expertise of a specialized unit for a more detailed investigation.

Some of the more noteworthy incidents the Patrol Division responded to while still in progress included a murder-suicide on Wilmer Ave, the accidental shooting and death of a Pennsylvania State Trooper at the Police Academy, the robbery of a 73 year old bar owner at the Plymouth Hill Condominiums, the pursuit and arrest of a home invasion suspect who threatened to kill the homeowner, a bomb threat at the Whole Foods, and the evacuation and decontamination of a neighborhood effected by a hazardous material crime scene.

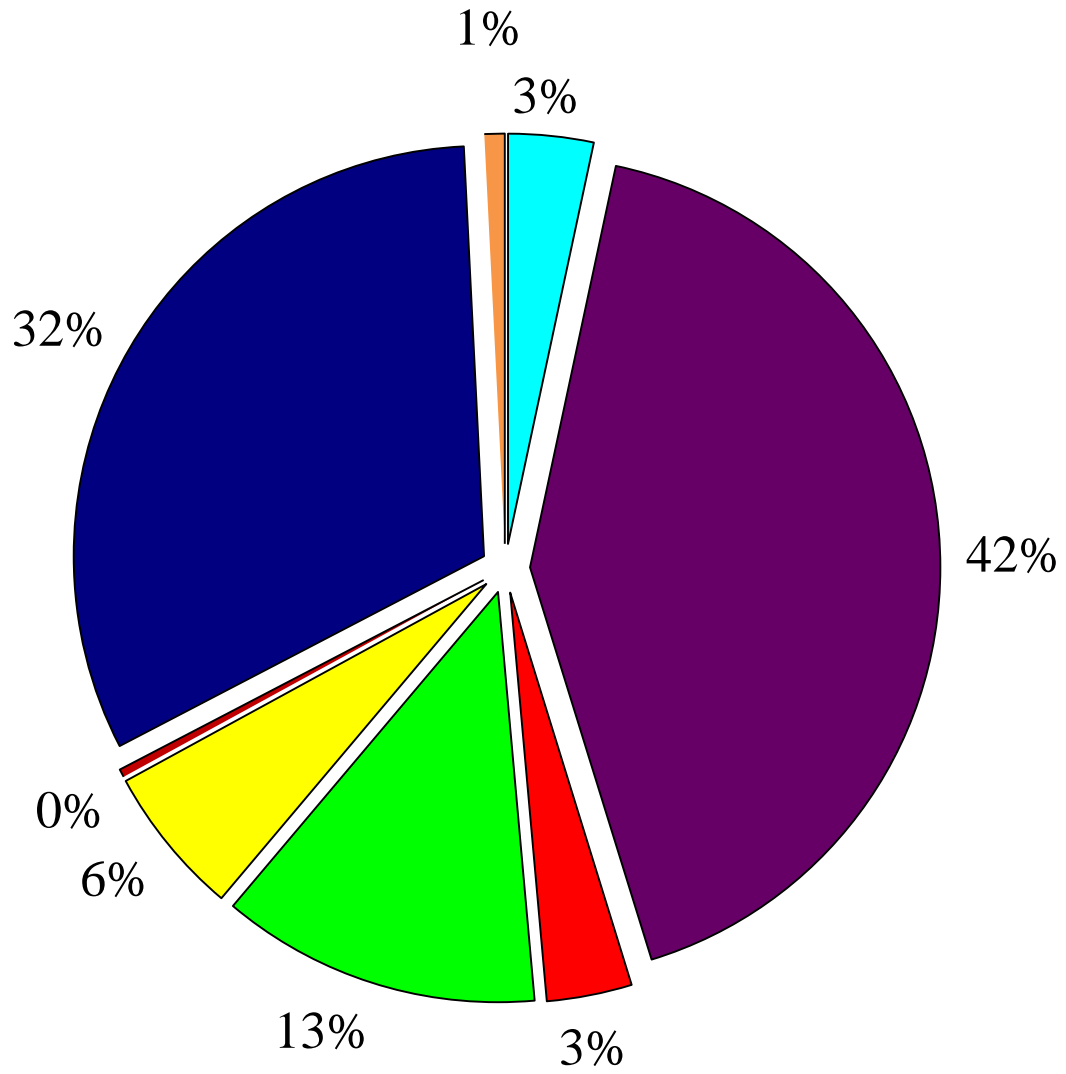
Just as importantly, the Patrol Division is highly visible and in constant contact with the citizens of Plymouth Township. Sometimes it is the more common duties of responding to an alarm at a home or business, helping a disabled motorist, giving directions, walking a foot beat or interacting with children that has the most impact on the Department's perception by our community. The men and women of the Patrol Division literally do these types of services thousands of time each year in all kinds of weather, and at times, in unfavorable conditions.

In 2014, Patrol Officer Kyle Wilhelm was publicly recognized as the Plymouth Township Police Officer of the Year. Officer Wilhelm is a squad 'Officer in Charge' (OIC), a member of Central

Montgomery County SWAT and a certified motorcycle operator. Patrol Officers were also recognized by the Township for their efforts in arresting three home invasion suspects following a pursuit, rescuing a female motorist from a burning vehicle, pursuing and arresting a suspect who fled into a Township home following a knife point robbery at a local convenience store, and safely subduing a mentally ill subject who charged officers with a knife after stabbing himself.

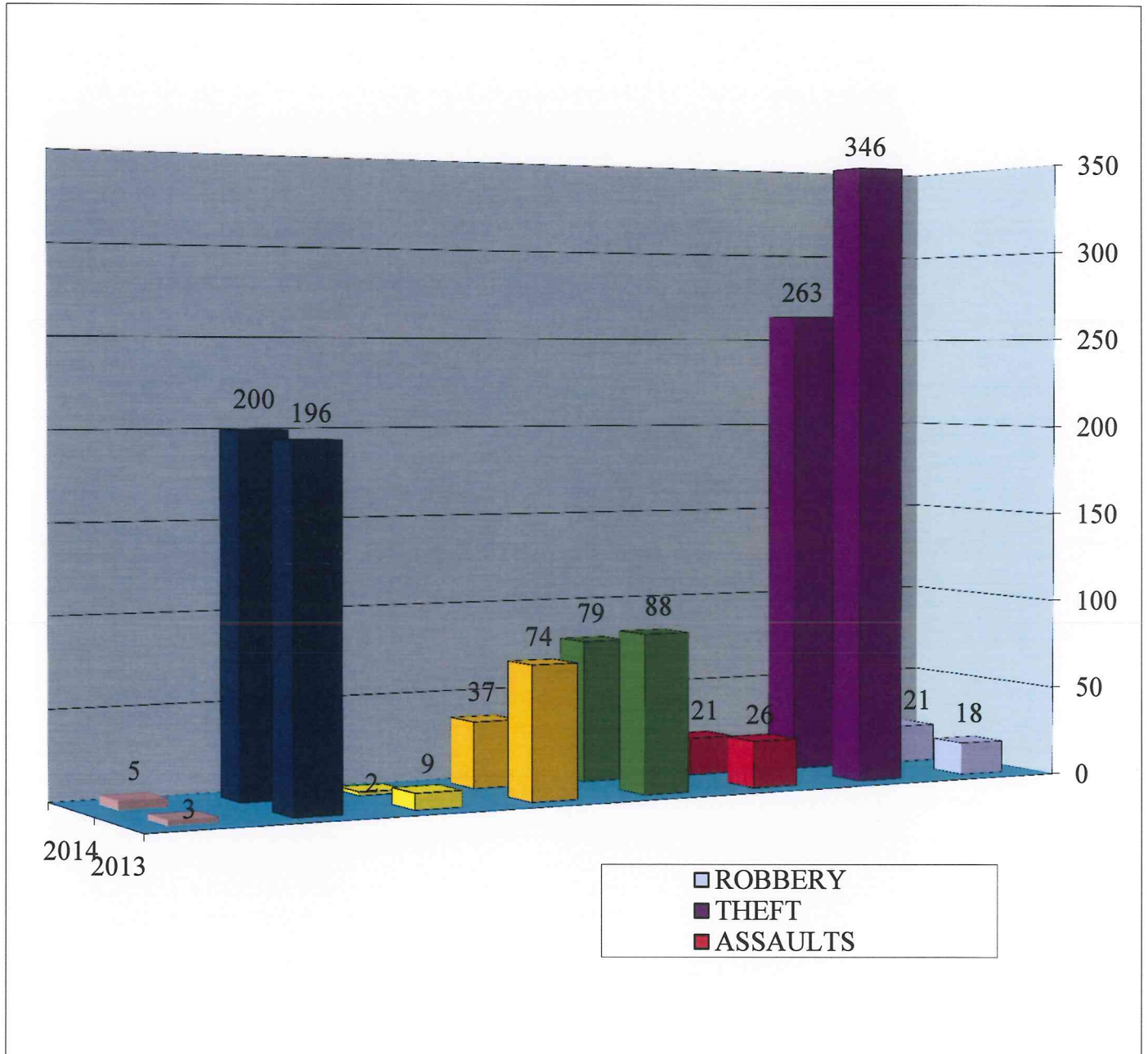
Officers of the Patrol Division are dedicated to protecting the citizenry of Plymouth Township and are committed to preserving the quality of life for our residents, business owners and visitors.

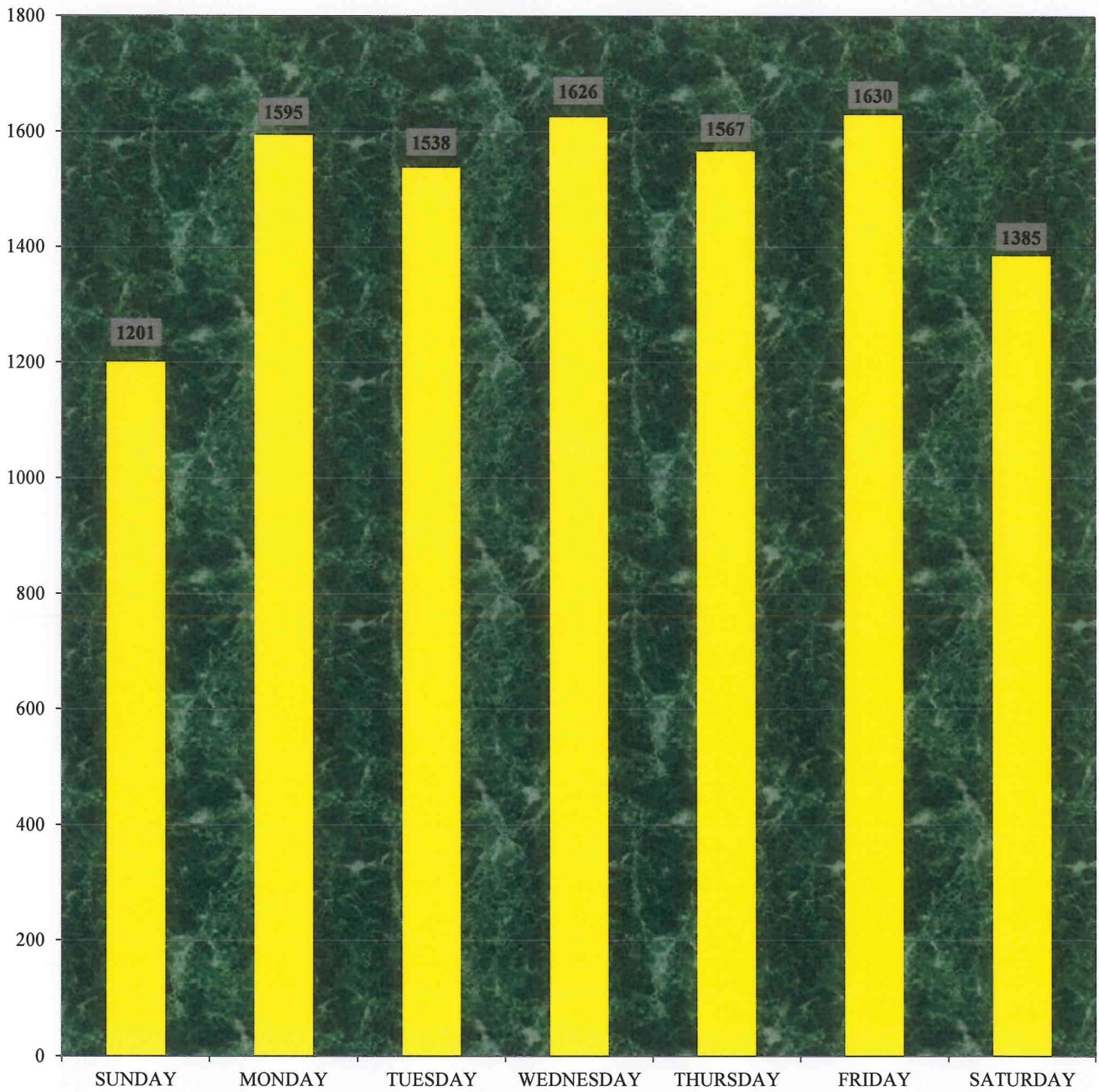

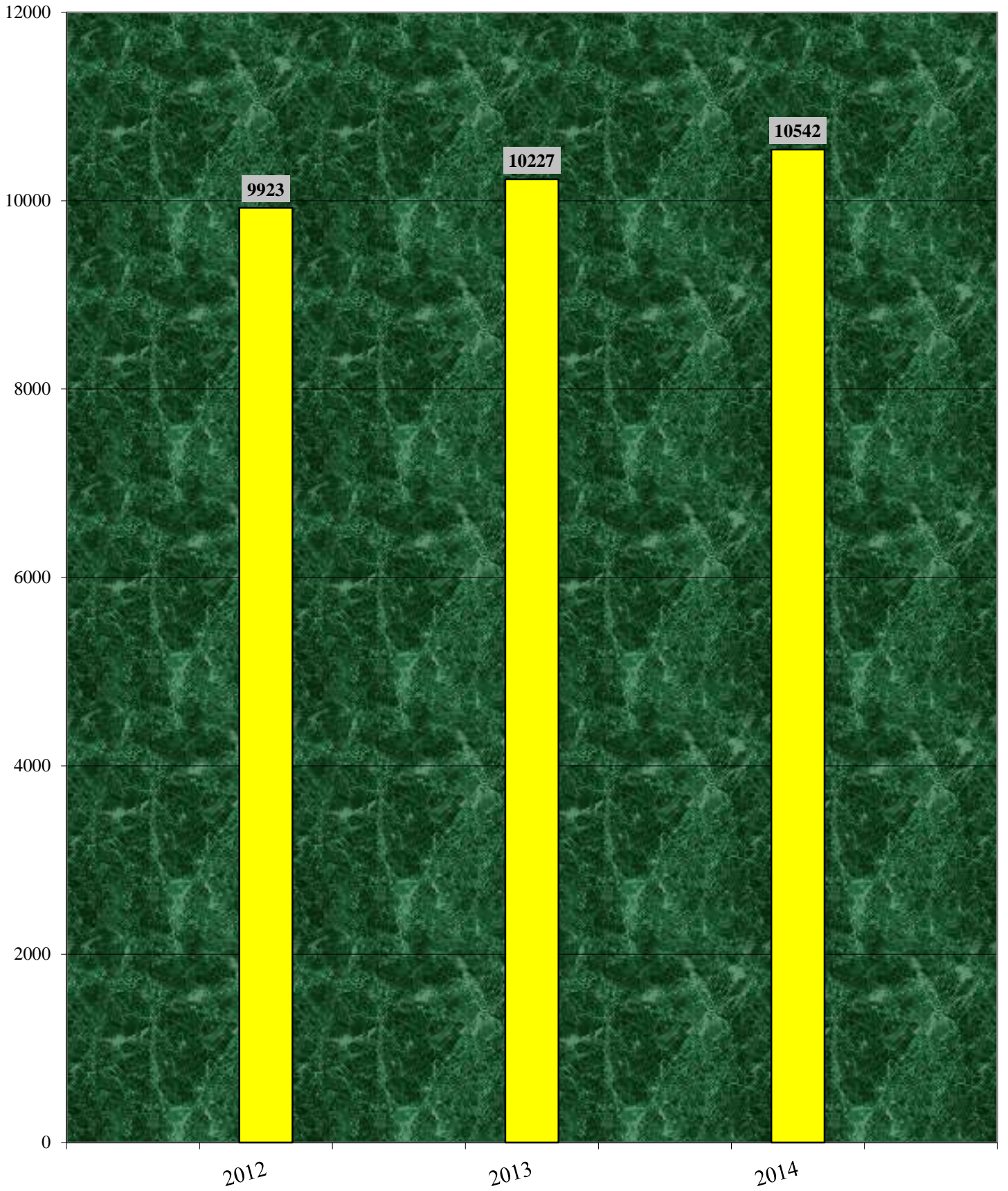
# Plymouth Township Police Department Two Year Serious Crimes Chart

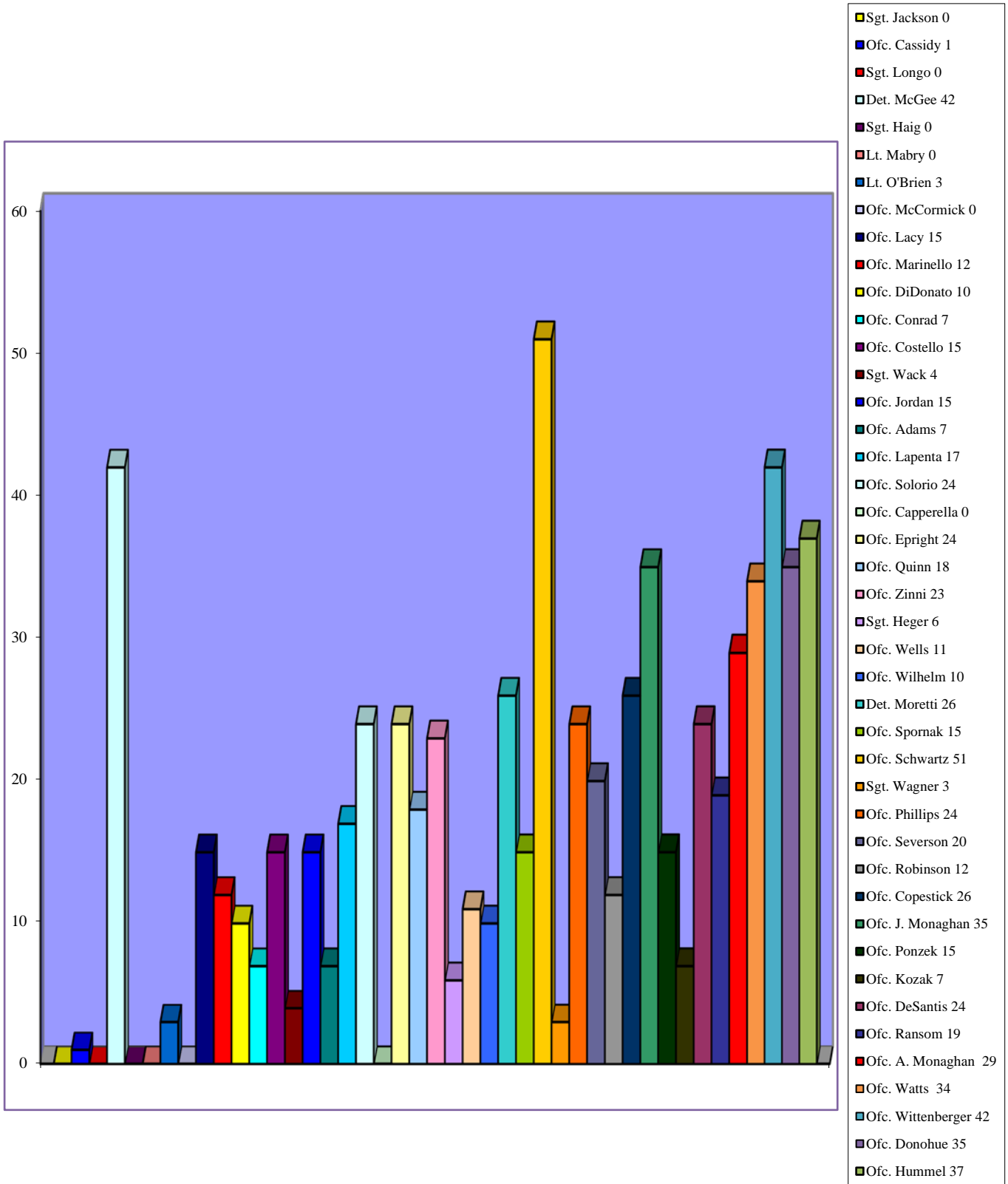

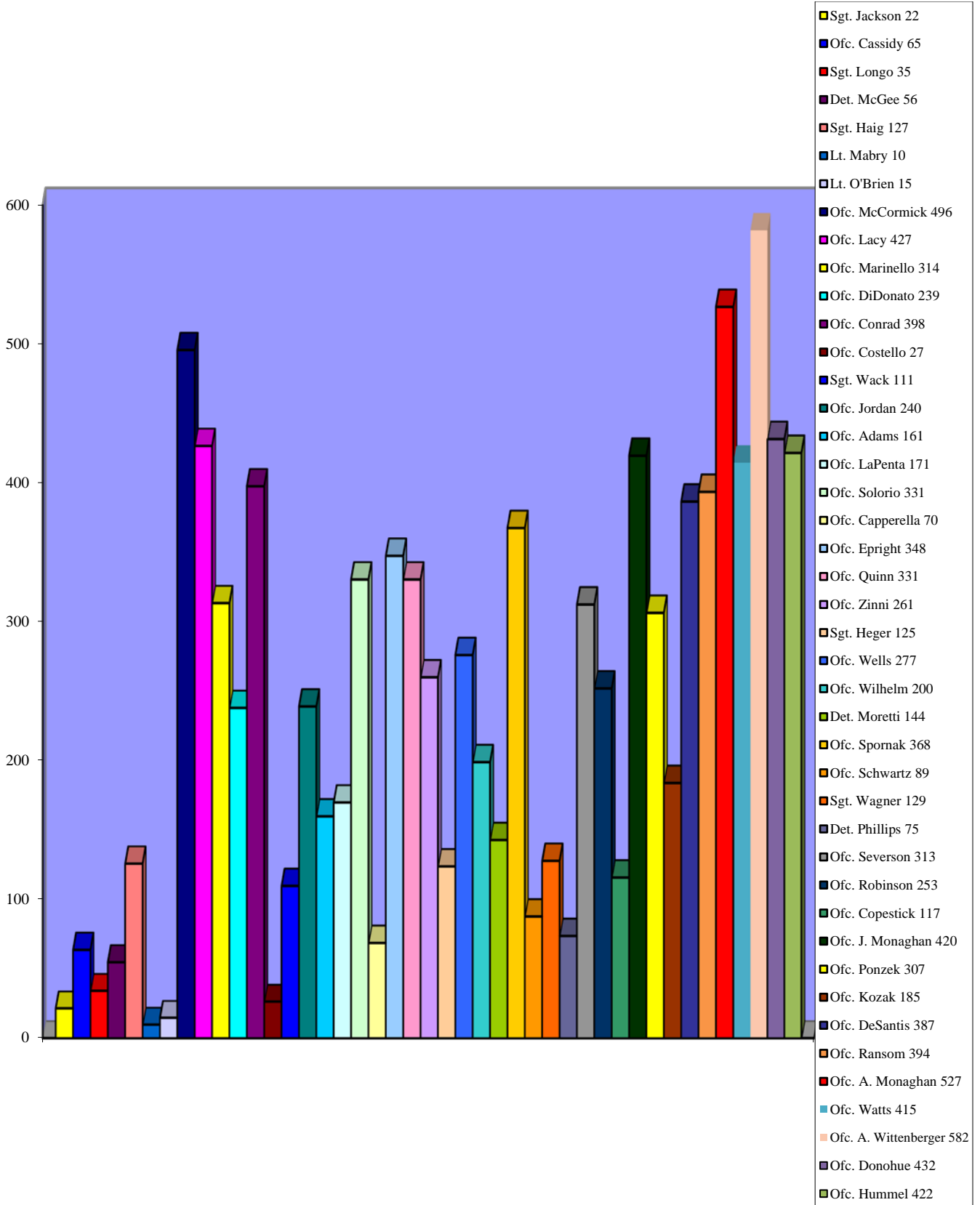

## **Plymouth Township Police Department Highway Patrol Unit**

Sergeant John Jackson leads a squad of four officers who comprise the Highway Patrol Unit. Officer John McCormick, Officer Mark Lacy, Officer Jeff Conrad and Officer Joseph Epright bring a combined service time of over 75 years to this Unit. Each of these dedicated Officers is trained in accident reconstruction and investigation, vehicle safety violations and the mitigation of traffic problems.

Officers responded to and investigated 1120 traffic accidents in the 2014 calendar year. There were 82 vehicle crashes involving injuries to 106 people. Sadly, there was one fatal crash in Plymouth Township during 2014. In September of 2014, the operator of a vehicle was killed as a result of a one vehicle crash on Conshohocken Road.

There were 1329 motor vehicle complaints handled in 2014. These complaints originate as parking complaints, disabled vehicles and reckless driver complaints. The Highway Patrol Unit processed 1417 abandoned vehicles during 2014. These are vehicles that were abandoned on both public streets and private property. Many of these vehicles created a hazardous condition and created travel and parking problems.

In addition to responding to citizen calls for service, the Highway Patrol Unit was also proactive in addressing criminal and traffic related problems. Officers of the Highway Patrol Unit frequently set up details targeting aggressive drivers, speeding and stop sign violations.

Officers of the Highway Patrol Unit conduct a high volume of traffic stops. As each of these Officers is trained in the identification and detection of drugs, several of these traffic stops have resulted in the arrest of subjects who have had outstanding warrants as well as arrests for various drug offenses.

Highway Patrol Officers also placed portable speed timing devices at locations throughout the township. These devices were able to record the speeds of motorists traveling on the roadway. This data was then later analyzed by Sergeant Jackson. The portable speed timing devices also serve as a reminder to vehicle operators to maintain a safe and legal speed on a given roadway.

An additional responsibility of the Highway Patrol Unit, is the coordination of the Police Department's Motorcycle Unit. In 2014, the Department added two 2015 state of the art Harley Davidson Electra Glide motorcycles, bringing our fleet up to a total of six. Pre-emption devices were added to all the motorcycles, as well as, advanced LED emergency lighting to improve the visibility and functionality of these motorcycles. The motorcycles are utilized for various aspects of policing, however, they are primarily used for traffic enforcement and routine patrol assignments. The police motorcycles are an integral part of the Highway Unit. Highway Patrol Officers respond promptly to crash scenes and other emergency calls by carefully maneuvering through heavy traffic which enables them to assist victims and open roadways more efficiently. The motorcycles also

enable our department to provide escorts and control traffic for large funerals, dignitaries, parades and other special events. During 2014, the Motorcycle Unit escorted participants of The Law Enforcement United while they rode their bicycles to Washington DC for National Police week.

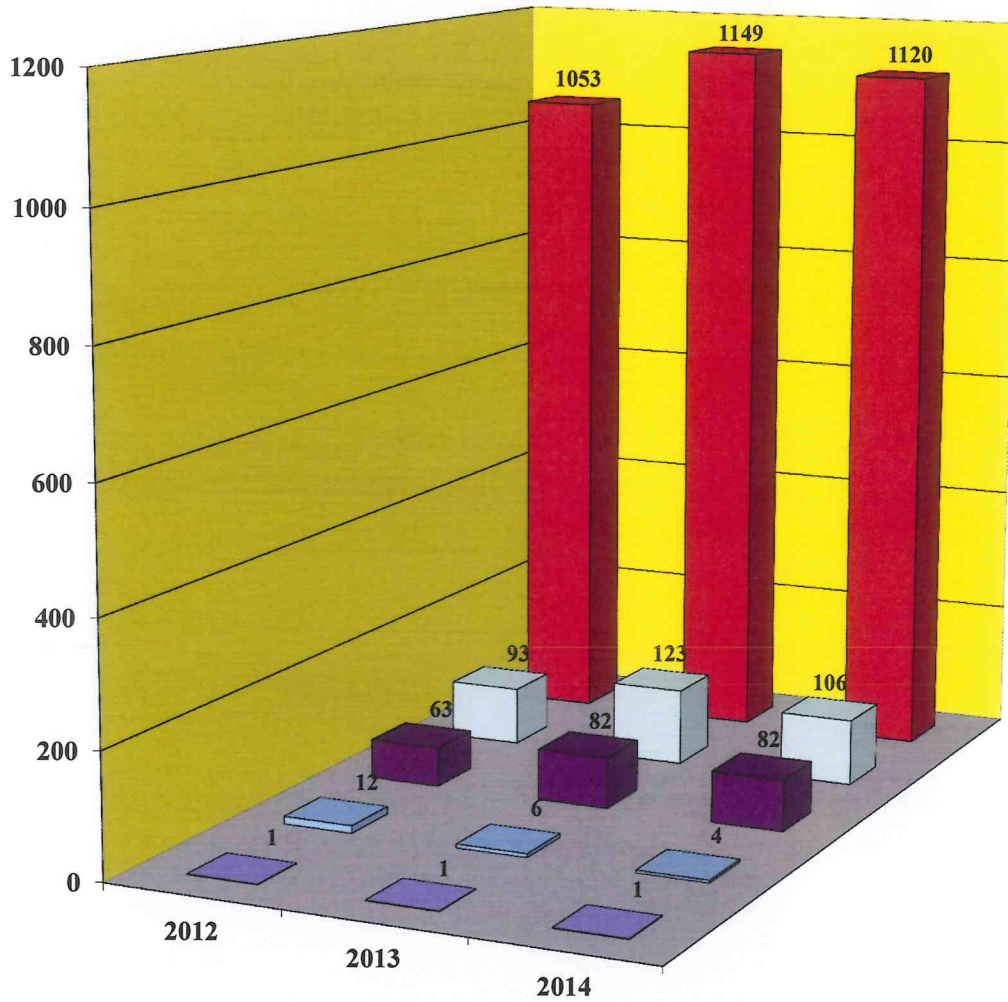

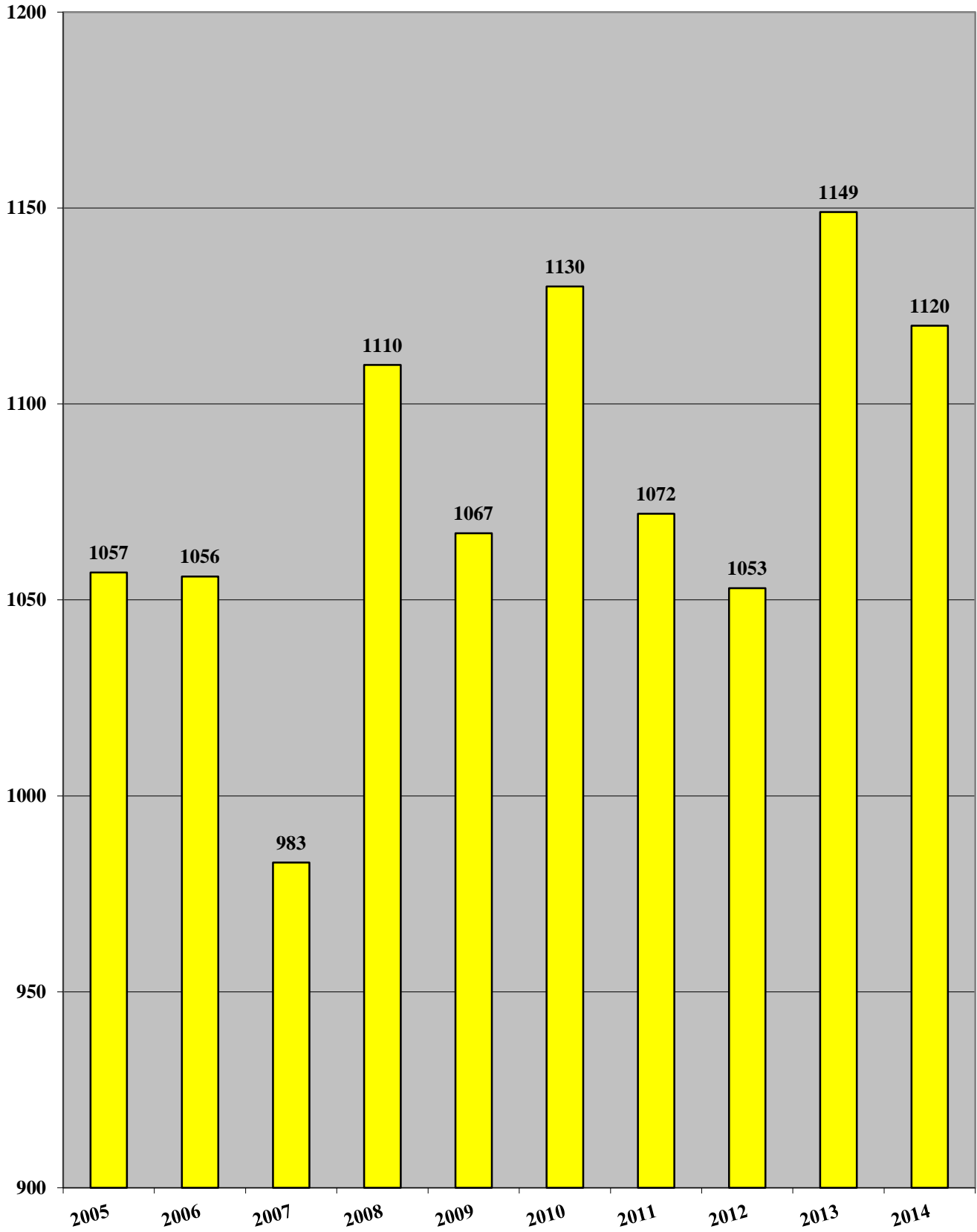

Three Year Chart**

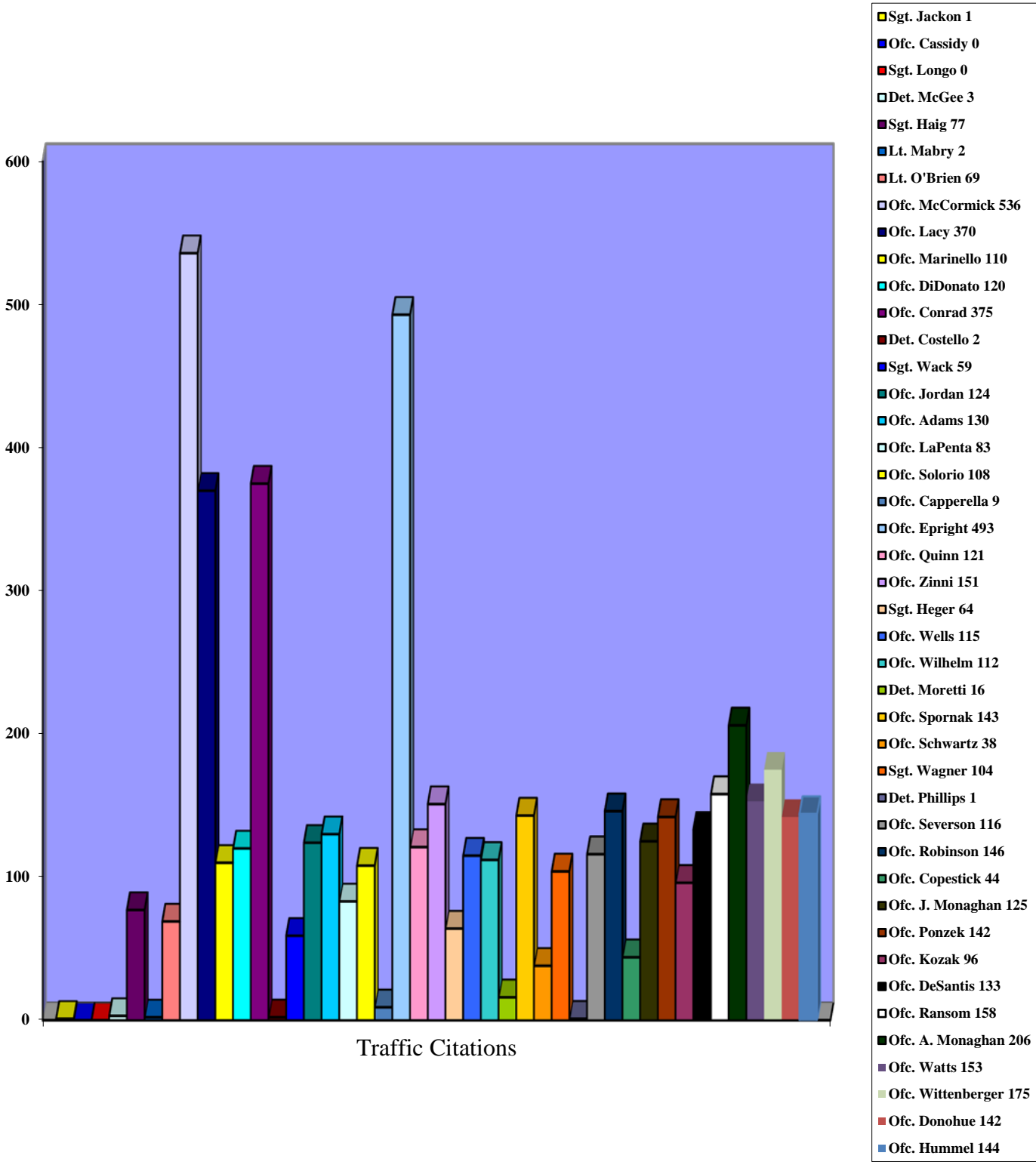

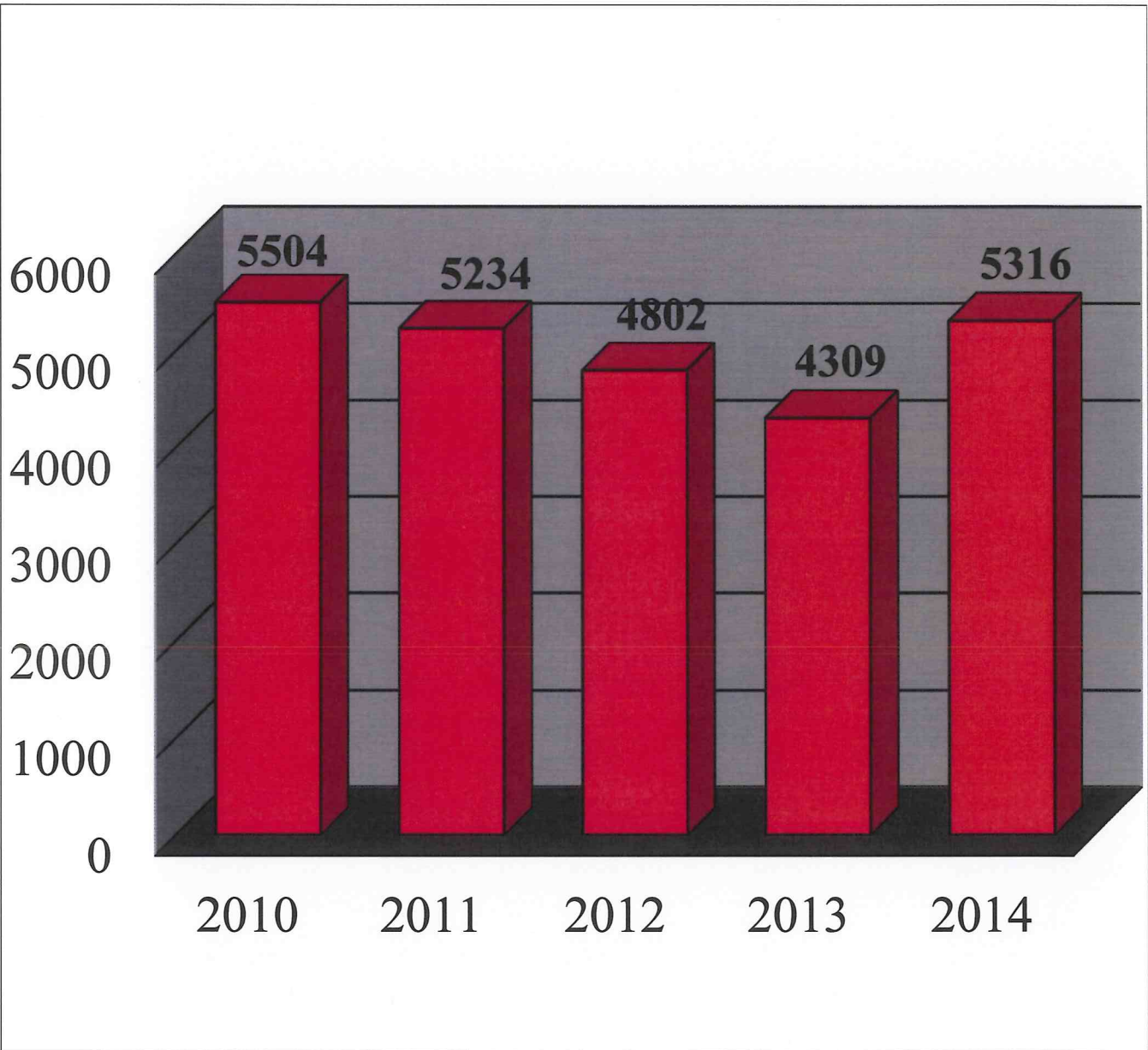
# Plymouth Township Police Department Ten Year Crash Chart

## **Plymouth Township Police Department K-9 Unit**

The Plymouth Township Police Department's K-9 Unit has now been in service for over twenty three (23) years, providing protection to the Plymouth residents virtually around the clock. This dedicated unit continues to train hard and work hard, setting the standard in this region as one of the premiere K-9 units. The K-9 Unit is widely respected, not only for the officers and their K-9 partners' dedication, but also for the Township's commitment to training, equipment and our facilities. This commitment and dedication has been demonstrated time after time over the years.

The Plymouth Township Police Department K-9 Unit consists of four handlers and their partners. All four are certified to work patrol duties. Two are also cross trained in narcotic detection with the remaining two cross trained in explosive detection. Each team trains two- 12 hour shifts a month in order to remain proficient at their specialty.

The two teams trained in Patrol / Narcotic detection are Officer Wells and K-9 Vilko; along with Officer Severson and K-9 Jinx. Officer Wells received a new partner in 2014 with the retirement of K-9 Judo. K-9 Judo served the residents of Plymouth Township and the entire Montgomery County community for many years. He is now enjoying a well-deserved retirement at the home of Officer Wells, who kept him after his service years were completed. In May, Officer Wells teamed up with his new partner Vilko, a two year old German Sheppard, and the team completed a training course at Castle K-9. On their first assignment together after graduating, they tracked and located fleeing suspects hiding in a garbage container in East Norriton Township leading to an arrest.

The two teams trained in Patrol / Explosive detection are Officer Jon Monaghan and K-9 Fox; along with the newly certified team of Officer Watts and K-9 Major. Officer Watts joined the K-9 Unit and his partner Major in 2014 when Officer Ponzek left the K-9 Unit. Officer Watts and his partner spent nearly three (3) months training at Castle Canine in 2014 in order to meet the high standards already established by this department and the K-9 Unit. K-9 Major was already a well trained and certified K-9 at the direction and supervision of Officer Ponzek, thus making the transfer to Officer Watts smooth and seamless.

Plymouth Township Police K-9 Units are used on a regular and routine basis within the Township. They were also called upon for assistance fifty nine (59) times by outside agencies in 2014. This is an increase of over forty (40) percent. Our K-9 teams have been utilized in the tracking of suspects for homicides, robberies, burglaries, stolen vehicles and mentally ill individuals. Additionally, they are requested by area schools for narcotics detection, they track for lost children, and they often search homes and businesses keeping officers safer.

Some notable K-9 responses in 2014 include; Officer Severson and his K-9 partner Jinx tracking and apprehending two suspects involved in a home invasion in Plymouth Township. Officer Monaghan and his K-9 partner Fox were credited with quickly clearing Whole Foods Market after a bomb threat was received during business hours. Additionally our K-9 units also responded to bomb threats in Upper Moreland, Upper Providence, Franconia, East Norriton and the Montgomery County Courthouse. K-9 units also responded and located an escaped prisoner from the Montgomery County Prison. They assisted in an armed standoff in Upper Gwynedd that

eventually led to a peaceful surrender, assisted Whitpain police in locating three burglary suspects, and assisted in locating a missing woman with mental health issues. Finally, several Plymouth K-9 teams were dispatched to search for a subject wanted in the murder of several family members in the Souderton, Lansdale and Lower Salford area. This was a national news story and the suspect was eventually located deceased by Plymouth Township Police Officers assigned to the Special Operations Team.

Our K-9 teams remain a popular attraction at community events both within Plymouth Township and surrounding municipalities. They continue to bring positive recognition to Plymouth Township, not just the Police Department. Plymouth Township Police K-9's performed several demonstrations in 2014 at various community events within and around Plymouth Township, mainly to school aged children.

## **Plymouth Township Police Department Detective Division**

The Plymouth Township Police Detective Division consists of three separate units, the Criminal Investigations Unit, the Special Investigations Unit and the Community Policing Unit. These separate units function independently and also in combination with each other as a single cohesive unit, as well as with all the other divisions of the Police Department. 2014 was a shining example of this as the Detective Division investigated many high profile cases that involved the members to mesh their investigative talents. The members of the Detective Division are dedicated, diligent, highly motivated and skillful, all of which is imperative in order to bring criminal investigations of crimes committed in Plymouth Township to a positive outcome.

The Detective Division is supervised by Detective Sergeant Thomas Longo. The other members assigned to the Division are Detective Jeffrey McGee Sr., Detective Anthony Costello, Detective Andrew Moretti, and Detective David Phillips. The Special Investigations Unit underwent a change, in May 2014 Officer Joseph Lapenta was reassigned to the Patrol Division after his 2 year assignment to the SIU. Officer Douglas Copestick was assigned to the SIU, joining Officer Christopher Schwartz. The Community Policing Unit is comprised of Officer Michael Cassidy and Officer Michael Capperella.

In 2014, members of the Detective Division were assigned 574 cases for investigation. The Detective Division was able to clear 76% of the cases assigned. Of the cases cleared, 50% of those cases were cleared with arrests. The Detective Division made a total of 219 criminal arrests in 2013.

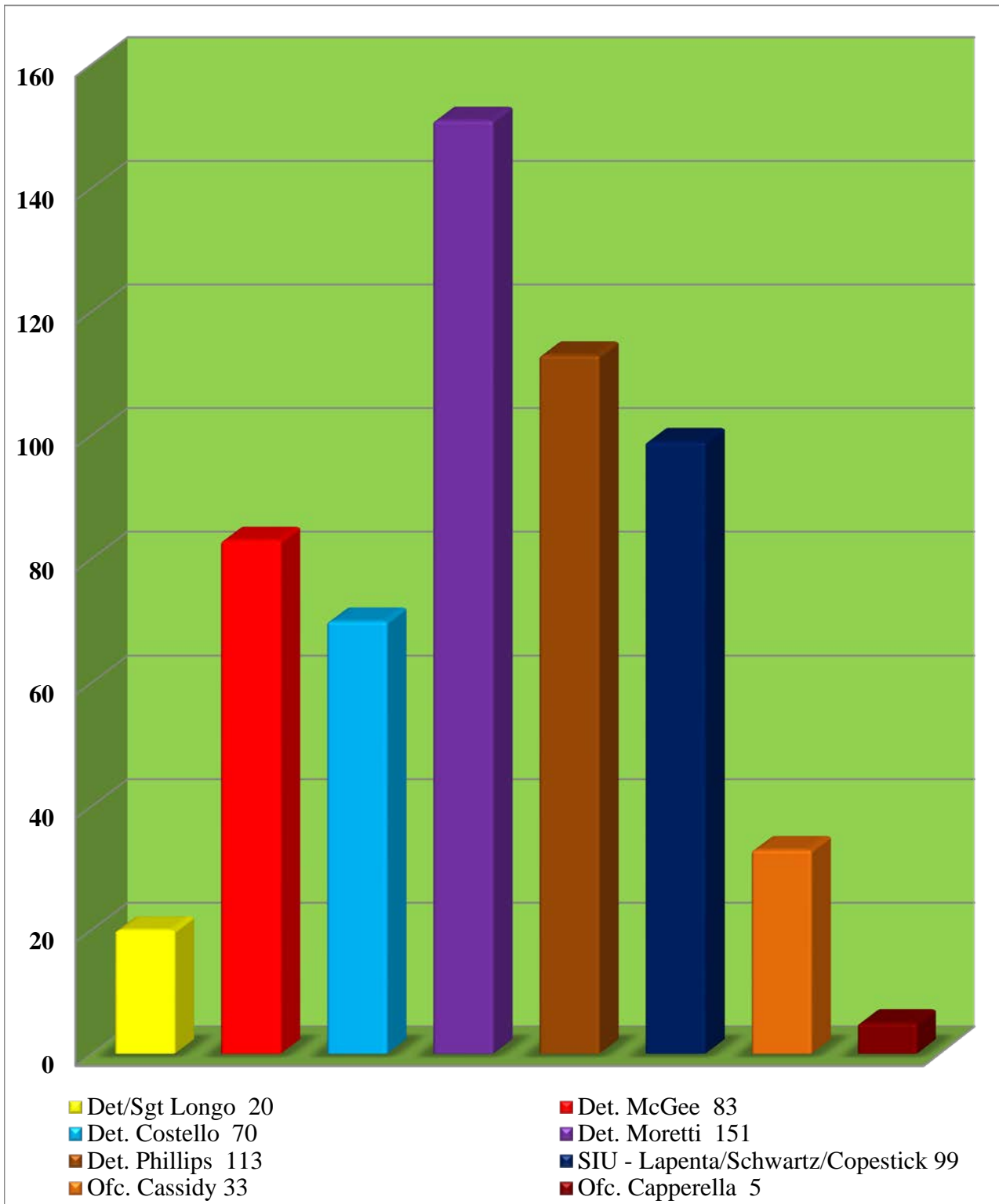
Some notable cases investigated and solved in 2014:

- Investigated three homicides.
- Arrest of a father and son for the murder of their father/grandfather - Jack St. Onge Sr.
- Investigation of the accidental shooting death of PA State Trooper David Kedra.
- Investigation of a husband/wife murder/suicide.
- Arrest of three suspects for a gunpoint robbery of a 73 year old Philadelphia bar owner at the parking lot of his residence at the Plymouth Hill Condominium.
- Arrest of two suspects for a home invasion burglary, in which they threatened to shoot the elderly female victim, both suspects were wanted for over 50 burglaries in multiple states.
- Arrest of an adult male for the statutory rape of a juvenile.
- Arrest of two suspects for the thefts of over \$50,000 of copper wire.
- Arrest of a three suspects for their involvement in "pocket picking" thefts in our movie theaters.
- Arrest of a suspect for the burglary of his next door neighbor's home in Plymouth Valley.
- Arrest of a suspect who risked a catastrophe by attempting to commit chemical suicide in his home, causing many of the residents of the Kennedy Crossing Development to shelter in place, and a major thoroughfare in the Township, North Lane, to be closed for 8 hours.
- Arrest of a suspect for a bomb threat at the Whole Foods Supermarket.

- Arrest of an adult suspect for harassing and stalking a juvenile at a school bus stop.
- Arrest of several suspects for trafficking narcotics in a multistate operation in conjunction with the Montgomery County Drug Task Force resulting in the seizure of approximately 7 pounds of marijuana.

The members of the Detective Division faced many difficult hurdles while investigating their case load this year. Many of these investigations entailed in depth investigative techniques which voraciously consumed the investigators' time and police department assets in order to bring about these successful conclusions. All of these investigations were handled with professionalism, diligence and the determination that has come to be the expected standard of all of the members of the Detective Division.

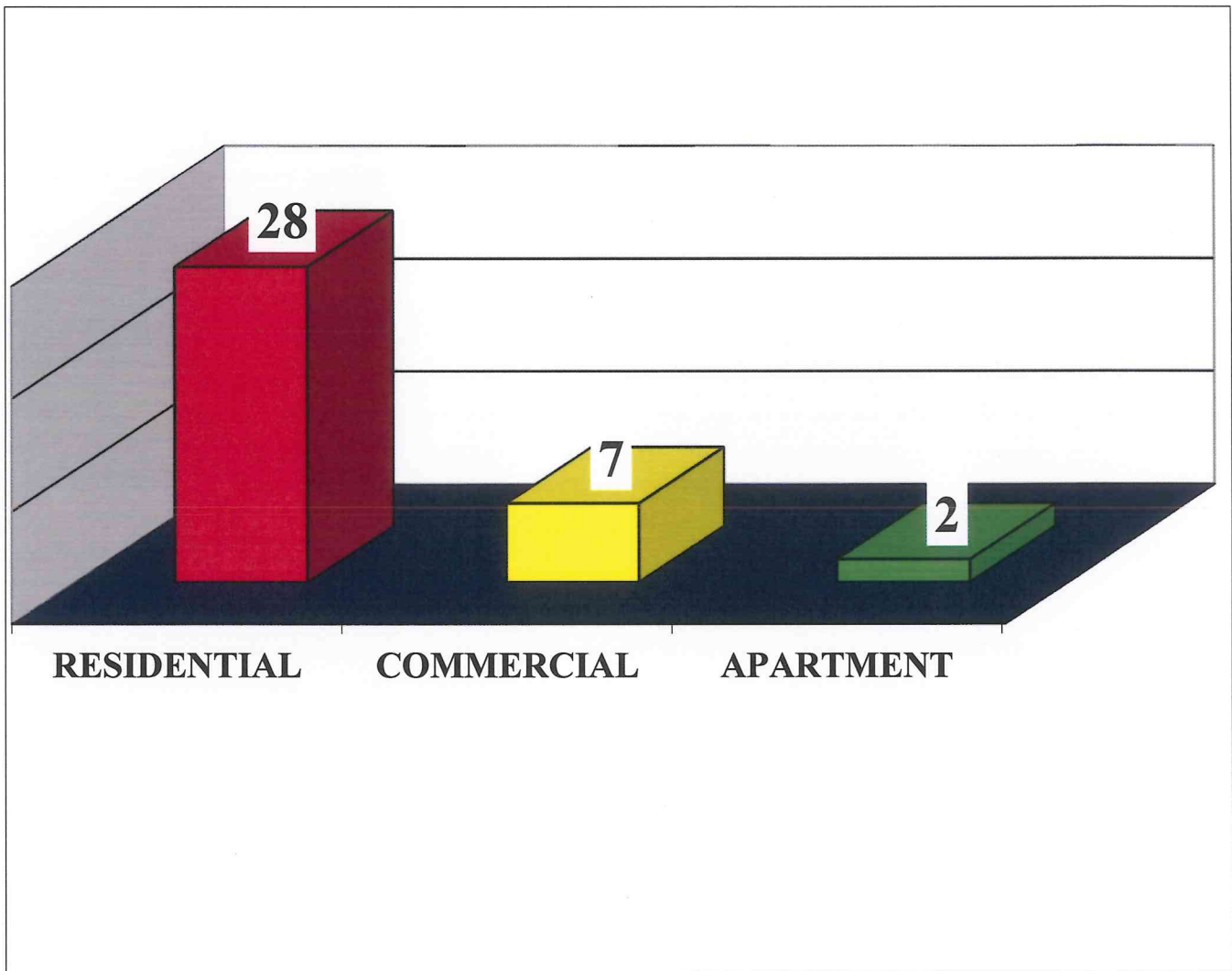
## Plymouth Township Police Department Cases Assigned by Detective



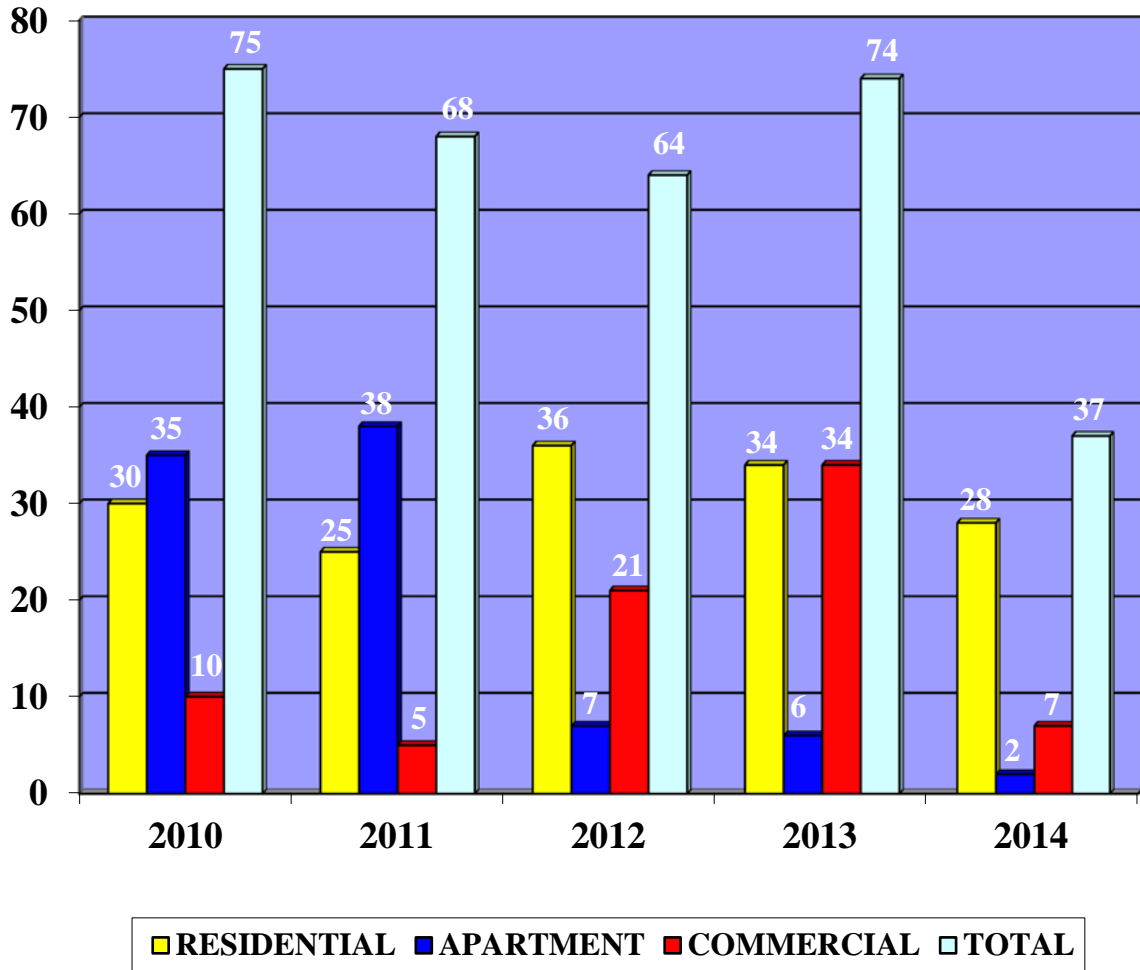

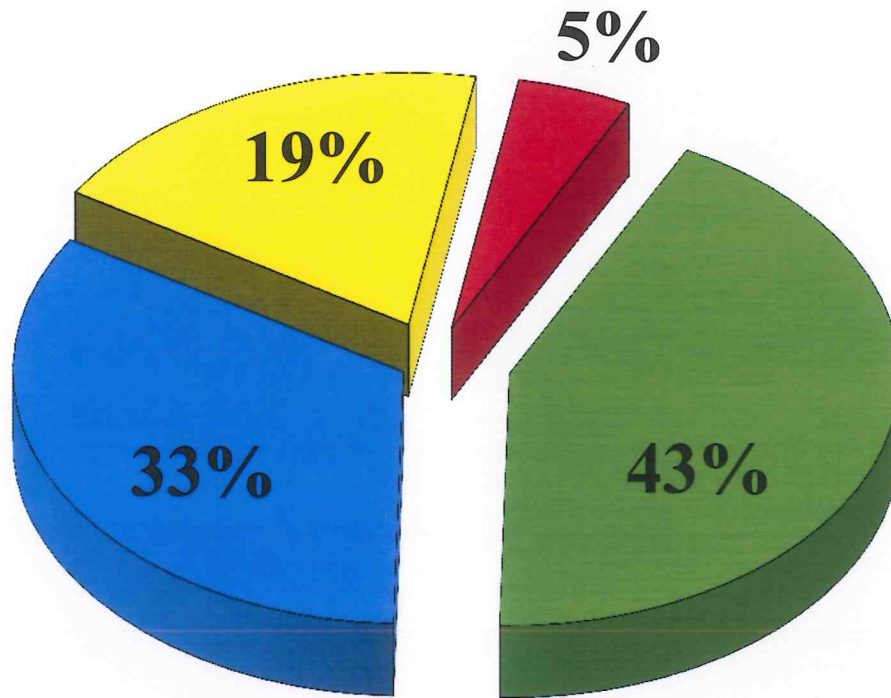

## **Plymouth Township Police Department Community Policing Unit**

The Plymouth Township Police Department's Community Policing Unit, or CPU, was formed in 2001 in response to the growing needs of the Community. The primary goal is to establish a collaborative effort between the police and the community (school, citizens, groups and businesses) in which we work together to identify and solve community problems. The Community Policing Unit consists of Officer Michael Cassidy and Officer Michael Capperella. Detective Sergeant Thomas Longo supervises the Unit.

The Community Policing Unit has conducted many programs throughout the year for our residents, school children, and businesses. These programs include: Be a Safety Kid/STAR Curriculum and Emergency 911 for Pre-School Children, Anti-Alcohol and Anti-Drug Classes, Anti-Bullying and Anti-Cyber-Bullying Programs, Internet Safety Programs, Identity Theft, Senior Citizen Fraud Programs and Active Shooter/Business Safety Program. The CPU assisted Township residents and businesses with employment fingerprinting and various personal safety seminars. The CPU also provides home security surveys to victims of burglaries, as well to any other resident that requests them. This same service is also provided to businesses. The CPU also conducts follow-ups with crime victims to make sure that they received Victim Services Forms if they were not provided one at the time their crime was reported.

The Community Policing Unit participated in several community events held within the Township. Events like Plymouth Township Day, Plymouth Township Fishing Derby, and other events. Every year the Plymouth Township Community Policing Unit partners with the Target Store, located in the Metroplex Shopping Complex, for the National Crime Night Out Event. This event is an opportunity for citizens to learn about various services offered to them through different organizations and agencies. This year we had over one dozen county and local agencies in attendance, as well as many vehicle displays and live demonstrations. This event alone attracted close to one thousand people.

The Community Policing Unit organizes and conducts holiday food and gift drives for Plymouth Township families in need. All members of the Police Department donate money and gifts needed for the November and December events. During the Christmas season, the Community Policing Unit again took a lead role in the 19<sup>th</sup> Annual Lt. Patty Simons – Law Enforcement Food/Toy Drive, which benefits the Montgomery County Salvation Army and other charitable organizations. Food and toys were donated from area businesses, schools and residents. The CPU took part in the food drive parade and assisted in the unloading of over seven tons of food and toys for the needy. The CPU also participated in the "Holiday Meals for Fallen Heroes" deliveries for Easter, Thanksgiving and Christmas Holidays.

The Community Policing Unit has an integral role in the Department's accreditation. The CPU, in conjunction with our Records Division, maintains all of the accreditation files and prepares them for our re-certification process. This is an arduous task and requires a tremendous amount of time to ensure the files are complete and accurate. This is an ongoing process that requires daily attention to verify that this department is complying with all 135 standards and 184 sub-standards.

Another function of the Community Policing Unit is to obtain and manage grants to fund several programs for the Department. In 2014, the Police Department obtained \$33,575.00 in grant monies. A breakdown of the funding sources include: Pennsylvania Liquor Control Board Grant (\$20,000.00), Pennsylvania Aggressive Driving Special Funding Grant (\$3675.00), Pennsylvania Aggressive Driving Grant Wave 1 (\$2,000.00), Pennsylvania Seat Belt Enforcement & Education Grant (\$3,600.00), Pennsylvania Aggressive Driving Grant Wave 2 (\$2,300.00) and Pennsylvania Aggressive Driving 2014-2015 Grant Wave 1 (\$2,000.00).

The Community Policing Unit continues to promote the Plymouth Township Police Department in a positive way to our residents, school children, and businesses. In doing so, the Community Policing Unit continues to further our community relationships.

## **Plymouth Township Police Department Special Investigations Unit**

The Plymouth Township Police Department's Special Investigations Unit was formed in 2007 in response to ongoing concerns and complaints of nuisance criminal activity, quality of life issues, and narcotics violations in Plymouth Township. In addition to aggressively combating local narcotics violations, the Special Investigations Unit also conducts surveillances in areas of known criminal activity and aggressively targets areas within the Township where criminal activity, such as vehicle thefts and burglaries, is occurring. The Special Investigations Unit also focuses on quality of life crimes such as prostitution, public drunkenness and the use of illegal narcotics in public places. The Special Investigations Unit frequently supplements the Detective Division by assisting in the many facets of the cases assigned for investigation as well as handling cases that are assigned directly to the Special Investigations Unit. Additionally, the Special Investigations Unit conducts aggressive targeted patrols in support of the Patrol Division.

In 2014, Officer Christopher Schwartz and Officer Joseph LaPenta III were assigned to the Unit from January through May. In May 2014, Officer LaPenta returned to the Patrol Division and Officer Doug Copestick was assigned to the Special Investigations Unit. Officer Schwartz and Officer Copestick served in the Unit for the remainder of 2014.

While investigating narcotics crimes in Plymouth Township, the Special Investigations Unit made forty-eight (48) arrests which resulted in the seizure of marijuana, THC wax / hash, cocaine, crack cocaine, heroin, ecstasy, marijuana candy, diazepam (Valium), clonazepam, alprazolam (Xanax), amphetamine / dextroamphetamine (Adderall), suboxone sublingual films, oxycodone (Percocet), amphetamine, tramadol, acetaminophen hydrocodone, lorazepam (Ativan) and assorted drug paraphernalia.

During 2014, the Special Investigations Unit prepared and served numerous search and seizure warrants related to their assigned cases, mainly dealing with the distribution and possession of illegal narcotics. These warrants are prepared based on probable cause relating to an investigation and authorize the officers to search and seize specific persons, places, vehicles and any other searchable items including cellular telephones, computers and financial records. The resulting searches and seizures provide evidence needed to bolster the successful prosecution of individuals involved in criminal activity in Plymouth Township. As a result of these executed search warrants, the Special Investigations Unit seized more than \$14,000 in US Currency; all of which has been or will be processed through the Montgomery County District Attorney's Office for forfeiture. These funds, when successfully forfeited as proceeds of illegal activity, are used to help Law Enforcement with the fight against narcotics distribution.

The Special Investigations Unit conducted numerous investigations that resulted in one hundred and one (101) arrests for criminal violations. The most notable cases are as follows:

- In March 2014, the Special Investigations Unit investigated a daytime residential burglary where the actors forced entry into the home of an eighty-six (86) year old resident while she was out shopping. A large amount of jewelry was stolen during the course of the burglary. The Special Investigations Unit developed a suspect and less than

24 hours later, executed a search warrant on the home of the actors. A large amount of the victim's jewelry was recovered and arrest warrants were issued for the suspects. After the burglary, the suspects fled to the beaches of Lee County, Florida. A week later, one of the suspects surrendered himself at the Plymouth Township Police Department while the second continued his attempt to flee justice by living on the beach. Ultimately, the second suspect was arrested by the Lee County Sheriff's Office, Fugitive Warrant Unit and was returned to Montgomery County to face prosecution. Both subjects are currently incarcerated at the Montgomery County Correctional Facility.

- In April 2014, a joint investigation into two subjects distributing heroin in Plymouth Township, Upper Merion Township and Bridgeport Borough was conducted by the Special Investigations Units from Plymouth Township and Upper Merion Township. As a result, five search warrants were executed at two residences, a vehicle and a storage facility, where one subject was residing inside a locker. The investigation resulted in the arrests of one heroin addict and two distributors of heroin. The outcome of this prosecution is still pending.
- In July 2014, the Special Investigations Unit conducted an investigation of a male subject in a Plymouth Township Apartment complex distributing high grade marijuana. As a result of the investigation, search warrants were executed on the apartment. Evidence seized in the apartment included approximately one pound of marijuana and more than \$7000.00 in US currency. The SIU continued this investigation and joined with members of the Coatesville Police Department / Chester County Drug Task Force to execute additional warrants on the Plymouth Township resident's marijuana supplier. Ultimately, an additional two (2) pounds of marijuana and more than \$2,000 in US currency were seized in furtherance of this investigation.
- In July 2014, while conducting surveillance in a restaurant / bar parking lot in Plymouth Township, the Special Investigations Unit witnessed a hand to hand drug transaction between a subject in a vehicle and an employee of the establishment. The SIU initiated an investigation and arrested the narcotics customer with a small amount of marijuana for personal use. The SIU immediately continued their investigation and within hours, arrested the restaurant employee with approximately one-quarter pound of marijuana. The SIU continued to press on in this case as defendants continued to cooperate. The SIU worked up the drug distribution ladder which culminated with the arrest of a drug mule from Colorado who was delivering four (4) pounds of marijuana via commercial airline. As a result of the total investigation which started with a one (1) gram bag of marijuana, the SIU arrested five (5) individuals and seized more than seven (7) pounds of marijuana plus the proceeds of marijuana sales. This case is noteworthy for more than the SIU's ability to work with confidential informants in their pursuit of the larger drug traffickers; in this case, the hierarchy of this drug organization was learned through interviews and investigation. On a monthly basis, the drug mule was traveling via commercial airlines with four (4) pounds of marijuana in a carry-on piece of luggage. Each time this subject flew on the commercial airline, the illegal controlled substances in his carry-on bag went undetected. This subject has been flying the illegal controlled substances to Pittsburgh, Philadelphia and Nashville, Tennessee on a monthly basis for the last several years.

Attempts to dismantle this drug Organization at the top were met with stiff resistance by Local, State and Federal Law Enforcement entities in the State of Colorado due to the state's legalization of the drug. Prosecution of the involved subjects of this investigation is still ongoing.

- In August 2014, the Special Investigations Unit conducted a joint investigation with the Upper Merion Township Special Investigations Unit attempting to locate two subjects wanted for a violent narcotics related home invasion in Upper Merion Township. Investigation revealed that the two suspects had been staying at hotels in Plymouth Township and switching hotels on a frequent basis in an attempt to remain free from prosecution. Both suspects were located in a Plymouth Township hotel and taken into custody. Evidence recovered in their hotel room indicated heroin use and likely prostitution was taking place. Prosecution of these two subjects is still pending.
- In October 2014, the Special Investigations Unit was assigned to investigate a strong armed robbery at a jewelry store in the Plymouth Meeting Mall. As a result of the investigation, a male and female couple was quickly identified and arrest warrants were issued. The suspects ultimately remained on the run while committing at least three bank robberies in addition to the jewelry store robbery. Both subjects are currently in custody awaiting prosecution.
- In November 2014, the Special Investigations Unit received information regarding a subject distributing high grade marijuana in close proximity to one of our schools. The SIU quickly developed a Confidential Informant and within weeks, secured a search warrant for the residence. In addition to nearly one half pound of marijuana that was seized, the SIU seized two pistol firearms, a shotgun, two rifles and an AK-47 assault rifle. The outcome of this case is still pending.

The Special Investigations Unit also works in conjunction with the Montgomery County District Attorney's Office Municipal Drug Task Force. The Task Force is a multi-jurisdictional organization comprised of more than 400 Police Officers from Montgomery County who are sworn as Special County Detectives for the purpose of narcotics investigations. The Task Force members may conduct investigations and make arrests anywhere in Montgomery County. Any investigation or other work performed as a Task Force member is over and above the normal course of duties for our Officers. There are currently twenty-two (22) members of the Police Department that are also members of the Task Force.

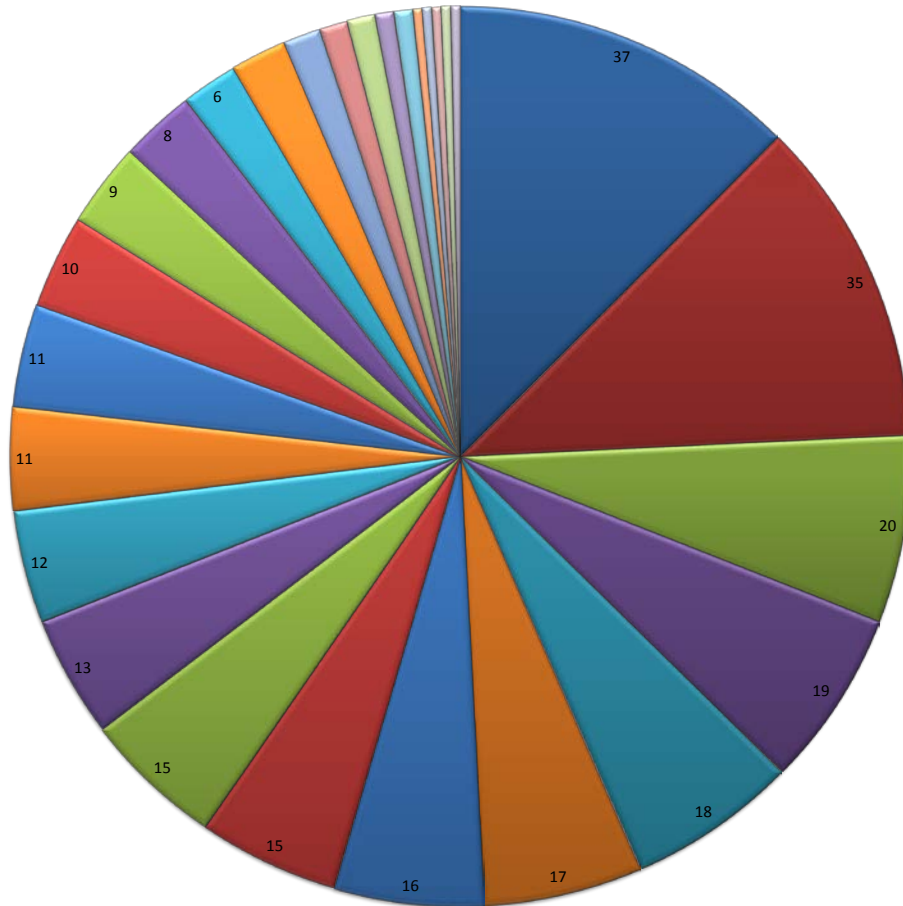
During 2014, members of the Drug Task Force worked in conjunction with other Task Force members to conduct narcotics investigations throughout Montgomery County. Plymouth Township Police Officers assigned to the drug task force worked jointly with members from the Conshohocken Police Department, Whitemarsh Police Department, Springfield Police Department, Cheltenham Police Department, Lower Gwynedd Police Department, Ambler Police Department, Upper Merion Police Department, Norristown Police Department, Lower Providence Police Department, East Norriton Police Department, West Norriton Police Department, Pottstown Police Department, Montgomery Township Police Department, DEA, PA State Attorney General's Office, PA State Police, Philadelphia Police Department, the

Montgomery County Narcotics Enforcement Team as well as other local agencies in five county Southeastern PA region.

The Special Investigations Unit continues to work in conjunction with the other units within the Plymouth Township Police Department as well as with outside agencies to rid Plymouth Township of narcotics activity, both on a large scale and a small scale. Those endeavors, as well as their attention to other nuisance criminal activity, help to make Plymouth Township a safe and healthy place to live.

Number of Counts of Criminal Violations - 2014**

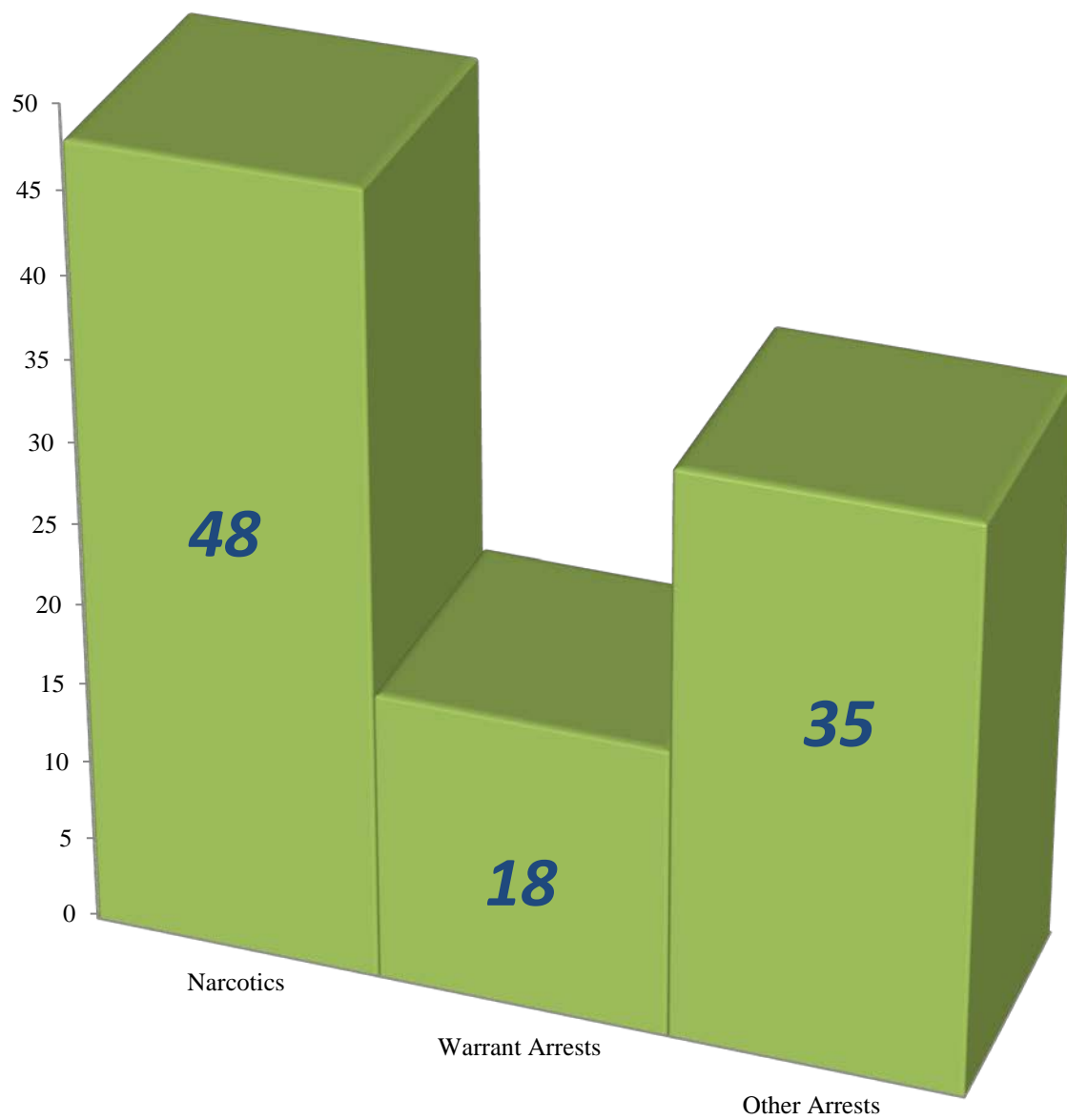

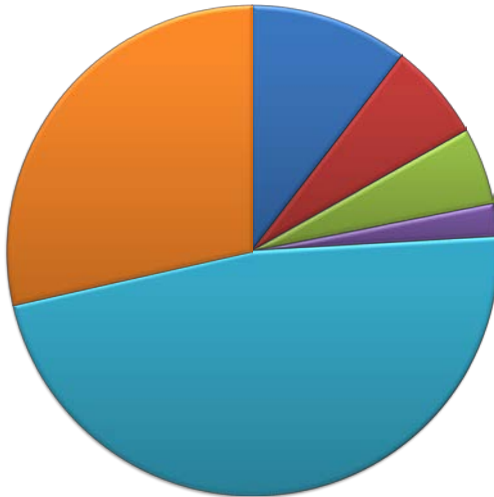

Arrests by Type - 2014



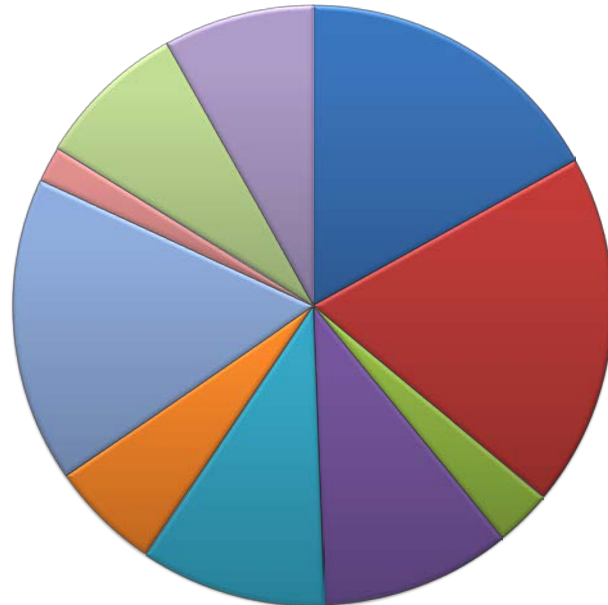

**Plymouth Township Police Department  
Central Montgomery County Special Weapons and Tactics  
(CMSWAT)**

The Central Montgomery County Special Weapons and Tactics Team (CMSWAT) is a multi-jurisdictional tactical team comprised of officers from fourteen (14) police departments throughout Montgomery County. This team is staffed, trained and equipped to handle high risk situations, such as armed individuals, that are beyond the capabilities of traditional law enforcement. CMSWAT is available for response 24/7, 365 days a year. The members of this team must meet rigorous entry standards to be selected and they must continue to maintain these high standards in order to remain active on the team. Members of CMSWAT must pass a physical fitness test twice a year, as well as pass monthly firearms qualifications. CMSWAT members once again attended a three (3) day training course at the Fort Dix Military Installation in New Jersey. This training consisted of live fire exercises and realistic training scenarios.

In 2014, the fifth full year of service with CMSWAT, the Plymouth Township Police Department detailed five (5) different officers to the team. Sgt. Wagner, Officer Wilhelm and Officer Adams are currently assigned as entry team members with Officer Adams holding a leadership position as an Element Leader. Detective Phillips continued on with his duties as a team marksman and Officer Zinni as a Crisis Negotiator. These officers maintained both their regular duties with the Plymouth Township Police Department as well as their CMSWAT responsibilities. CMSWAT continues to meet the national standard (16 hours) for training each month as set forth by the National Tactical Officers Association.

In 2014, CMSWAT began preparations to absorb the North Penn Tactical Team in early 2015. This merger will add several more jurisdictions to CMSWAT'S area of responsibility. Training between the two units during 2014 will ensure a smooth transition next year.

Officer Dave Zinni is in his third year as a Crisis Negotiator for the team. Officer Zinni attends regular training and is readily available to assist the team whenever he is called upon.

As a member agency of CMSWAT, Plymouth Township is provided with the tactical services of a highly motivated and extremely professional tactical team. The Department's affiliation with CMSWAT provides valuable free training opportunities to patrol officers through Urban Patrol Rifle schools and various tactical training sessions. Ultimately, this affiliation provides our citizens and officers with a higher level of safety during any crisis situation.

In December of 2014, a tragic domestic murder spree occurred throughout several jurisdictions in Montgomery County. This murder spree resulted in multiple deaths and one person being seriously harmed. Once again, CMSWAT was called upon to assist at numerous crime scenes as the events were unfolding. It was Plymouth Sergeant Brian

Wagner, while assigned to CMSWAT, who located the deceased perpetrator during an area grid search in a neighboring county. It is precisely this type of criminal activity that CMSWAT is trained and prepared for.

**Plymouth Township Police Department  
Major Incident Response Team  
(MIRT)**

The Montgomery County Major Incident Response Team (MIRT) is comprised of a contingent of officers formed from police departments throughout Montgomery County. The team is jointly funded by the member departments, as well as the Department of Homeland Security. MIRT was developed to better handle large events, civil disturbances, natural/manmade disasters, and chemical/radiological/biological terrorist incidents.

The Plymouth Township Police Department has dedicated three (3) officers to MIRT. These officers have assumed the additional responsibilities that come with this county-wide team, above and beyond their normal duties as Plymouth Township Police Officers. All officers on MIRT are trained by Homeland Security for Field Force Operations (civil disturbances). They are also trained on how to respond to a chemical, radiological, and/or biological terrorist attack. As a result, all MIRT members have been issued special equipment for dealing with these types of incidents.

Recent national events that have occurred in both the Midwest and the Northeast demonstrate all too well the need for a well-trained, well equipped and disciplined field force capable of dealing with large scale protests, civil disturbances and criminal behavior.

During 2014, MIRT officers received training from the Department of Homeland Security and the Philadelphia Police Department's MIRT Team. The training was in the following areas: Treatment of Life Threatening Gun Shot Wounds, Screening of Persons by Observational Techniques, Sustain Liberty Training Exercise, Site Protection through Observational Techniques (Train-the-Trainer), MIRT-Bike Response Training, Legal Updates for Civil Disturbances, and MIRT-Decontamination Training.

## **Plymouth Township Police Department Records Division**

The Records Division is staffed by Administrative Supervisor Sabrina Evangelist and Evidence Custodian Jennifer Brooke. The Records Division is an essential part of the Police Department and works extensively with federal, state and local law enforcement agencies conducting background investigations.

The Records Division also prepares cases for submission to the Montgomery County District Attorney's Office, conducts local record checks for the Montgomery County Sheriff's Gun Licensing Department and provides arrest information to various probation departments and victim services. Reports are available to victims and can be provided through the mail or in person during normal business hours, Monday through Friday from 8:00 a.m. to 4:00 p.m. In addition, the Records Division works in conjunction with our Community Policing Units in maintaining all of the accreditation files and preparing them for our recertification process.

As the evidence custodian Jennifer Brooke is responsible for ensuring the chain of custody and storage of evidence. Jennifer works directly with the officers and continues to purge and or destroy evidence as allowed by the case. Jennifer is also responsible for overseeing the destruction of weapons (non-firearms) and firearms.

## **Plymouth Township Police Department Communications Center**

The Plymouth Township Communications Center is staffed 24 hours a day, 365 days a year and provides personal assistance to the residents, businesses and visitors of Plymouth Township.

The Communications Center is headed by Administrative Supervisor, Sabrina Evangelist. It is staffed with four full-time dispatchers: Karen Bowman, Phil Smith, Lacey Smith, and Lisa Rumler. We also have 12 part-time dispatchers: Caitlyn Bonner, Eileen Blattner, Jonathan Davidson, Daniel Fox, Mandy Huff, Michael Italia, Patricia Karaffa, Annamaria Mastrocola, Joshua Stouch, Richard Tarozzi, Jessica Tomaselli, and Elizabeth Trandahl.

Our dispatchers assist officers with records checks on vehicles and suspects, as well as assisting those who call or come in for non-emergency requests. The Communication Center is outfitted with seven large screen monitors that view twenty-three intersections throughout the township. Our dispatchers often observe vehicle accidents or crimes in progress and immediately dispatch officers to the scene. In addition, our dispatchers are required to monitor thirty-one in-house cameras, which display all areas of the Township building to include our secure prisoner facility. Dispatchers ensure the safety of our prisoners through constant video and audible monitoring and alert officers in the event of a problem. All personnel in the Communications Center also enter reports into our records management system, fulfill requests from insurance companies for accident reports, and assist the Records Division when needed.



## **Plymouth Township Fire Marshal's Office**

The Plymouth Township Fire Marshal's Office is responsible for the investigation of all fires, the enforcement of fire codes for existing structures, and the promotion of fire safety through educational programs. The Fire Marshal's Office is staffed by Fire Marshal Andrew Mount, part time deputies Marty Rafter, Matt McCloskey, newly hired Michael Matusheski and Jim Behr who assist FM Mount with fire investigations and fire lane enforcement. Part time Fire Inspector Julie DeOrzio assists by conducting fire inspections of existing structures. The Fire Marshal reports directly to the Plymouth Township Public Safety Director, Chief Joseph F. Lawrence.

The Fire Marshal's Office responded to one hundred sixty (160) incidents and investigated twenty nine (29) fires in 2014. There was one fire incident requiring criminal prosecution in 2014.

In addition to fire investigations, the Fire Marshal's Office is tasked with the coordination of an emergency management system in the event of a catastrophe. Fire Marshal Andrew Mount has been designated as Plymouth Township's Emergency Management Coordinator, and Plymouth Township Police Lieutenant Karen Mabry is his Deputy Coordinator. Only one incident (winter storm) in February caused damage and loss of power to a large portion of Plymouth Township, however damage was not sufficient to support a Commonwealth or Federal emergency declaration required to allow for storm cost re-imbusement.

The Fire Marshal's Office works closely with the Police Department, both Township fire companies, and Plymouth Community Ambulance and is committed to the well-being of our residents. We will continue to keep our community safe through inspections, fire prevention programs, and the promotion of fire safety education to our Township's residents.



## **Harmonville Fire Police Annual Report**

The Fire Police of the Harmonville Fire Company fall under the jurisdiction of the Chief of Police. They have continued to prove that they are a vital and necessary asset to the operation of the Police Department. These dedicated volunteers provide effective assistance to the police at traffic accidents, road closures, fire calls and other serious incidents requiring well-trained personnel. They are also an important part of community events such as a monument dedication, a parade, a charity run or race and Plymouth Township Day; to name a few.

Captain Zip Rota is the officer in charge of this dedicated group of volunteers. Captain Rota receives valuable assistance from Lieutenant Frank Solomon as well as Sergeants Ray Naylor and Dave Colucci. The following personnel make up the volunteers of the Harmonville Fire Police: Jennifer McGuigan, Tom Glenwright, Barbara Spilove, Stan Spilove, Vince Gillen, Mary Jane Rodziak, Michele Solomon, Elisa Goldman, Paul Wolfe, Ed Albert, Laura Yeager, Dan Sharapan, Jim Nolan, Robert Evans, Tony Costa, Dave Marks, George McKinney, Dennis Gravinese Jr, and Robert McGuigan.

The Harmonville Fire Police responded to a total of 711 calls for service; including Alarms, Alarms Assisting Police and Special Service Alarms Assisting Police in 2014. This an increase of 8 calls for service from 2013 and an increase of 102 since 2012. The total number of Fire Police officers in service for these calls was 725 officers for over 1,012 hours of volunteer service. Both the number of officers, and the hours of service provided, is an increase over 2013. The officer increase is 20 and the hourly increase is approximately 30. The hours of service has grown by more than 345 since 2012.

The Harmonville Fire Police now track the total number of officers and officer hours in service. The unit no longer conducts calculations based on individual services, but as a total instead. The Harmonville Fire Police did assist the Plymouth Township Police forty nine (49) times in 2014. This is an increase of two (2) over 2013 and ten (10) over 2012.

Every hour that the Harmonville Fire Police volunteer to the citizens of Plymouth Township, and Montgomery County, is an hour that enables sworn police officers to be available for other emergency calls and services.

## **Plymouth Fire Police Annual Report**

The volunteers that make up the Fire Police of the Plymouth Fire Company continue to provide an invaluable service to the Plymouth Township Police Department as well as the entire Plymouth Township community. These professional, dedicated and well trained volunteers donate their time and service in order to allow the sworn officers to be available to handle additional calls for service. The Plymouth Fire Police respond to serious vehicle accidents, road closures, fire calls and numerous other serious incidents and special services. Their assistance is an invaluable part of the overall public safety system in place for the citizens of Plymouth Township.

The Plymouth Fire Police, who fall under the command of the Chief of Police, are led by Captain Adam Heffelfinger. Captain Heffelfinger receives valuable assistance from Lieutenant Fran Thomas.

The Officers of the Plymouth Fire Company Fire Police unit continued to make training a top priority in 2014. The unit also upgraded its traffic unit with some improved emergency lighting as well as a large LED arrow board. This arrow board provides assistance to the Fire Police Officers with traffic direction during road closures.

The Plymouth Fire Police responded to a total of 180 calls for service in 2014, a slight increase over the previous year. The Fire Police recorded 269 Fire Police Officers in service for over 121 total hours. They responded to specifically assist the police for 17 service calls with 21 Officers for over 17 hours. The numbers of police assist calls nearly doubled during 2014, with the number of officers and hours served also increasing. Finally, the unit also recorded 7 special service responses with 13 officers for approximately 27 hours.

## **Plymouth Township Police Department Training**

The Plymouth Township Police Department continues to strive to be the best in all aspects of law enforcement, including training. In 2014 the Department had, as the state mandates, all of our officers recertified under the requirements set forth by the Municipal Police Officers Education and Training Commission. Officers also received training in hazardous materials awareness for first responders, recertification for first aid, CPR as well as the use of the AED, and Taser. Numerous officers were sent to training seminars covering topics from officer safety, drug investigations, police supervision and standardized field sobriety testing.

Firearms training and qualification are both state mandated and a high priority for the Plymouth Township Police Department. The quality of service we provide to our citizens, and the protection we afford them and our police officers, is directly affected by the level of training an officer receives and the equipment they carry.

The quality training our officers receive, along with their desire to improve themselves, decreases the risk to the public and our officers when there is a need to take action and respond to emergency situations.
